CONDITIONAL ADMINISTRATIVE ORDER
AND NOTICE OF RIGHT TO BE HEARD

COMES NOW the State of Oklahoma, ex rel., John D. Doak, Insurance Commissioner, by and through counsel and alleges and states as follows:

JURISDICTION

1. John D. Doak is the Insurance Commissioner of the State of Oklahoma and as such is charged with the duty of administering and enforcing all provisions of the Oklahoma Insurance Code 36 O.S. §§ 101-7004 and the Oklahoma Bail Bond Act 59 O. S. §§ 1301-1340.

2. Respondent Raemona Perry is a licensed bail bondsman in the State of Oklahoma holding license number 90241.

FINDINGS

1. On or about June 13, 2007, an appearance bond was executed as follows:

Defendant:	Michael Danley
Case Number(s):	CF-2007-273
City/County:	Pontotoc County
Bondsman:	John Ensey
Surety:	Louis Perry
Power Number(s):	011967
Bond Amount(s):	\$300.00

2. On July 25, 2007, the Defendant failed to appear and the bond was declared forfeited. An Order and Judgment of Forfeiture was issued by the district court on August 27, 2007, and filed in the case. A true and correct copy of the Order and Judgment of Forfeiture was mailed to Louis Perry with return receipt requested within thirty (30) days after the forfeiture.

3. Louis Perry received a copy of the Order and Judgment of Forfeiture but failed to date the return receipt.

4. The ninety-first (91st) day after the Order and Judgment of Forfeiture was mailed was November 26, 2007. Louis Perry received a total of eleven extensions from the district court in which to return the Defendant to custody. The final deadline set by the court was September 3, 2010. The Defendant was not returned to custody within the time period set by the court, nor was sums due on the forfeiture deposited with the court clerk on the day after the deadline set by the court.

5. Louis Perry passed away sometime in 2010. Respondent, Raemona Perry, requested and received permission from the Oklahoma Insurance Department to act as a professional bondsman in regards to the business of Louis Perry. Respondent was acting as a professional bondsman with regards to the business of Louis Perry at the time the court ordered deadline referenced above passed.

6. The forfeiture has been neither paid nor exonerated.

CONCLUSIONS

The allegations are found to be true and correct and Respondent has violated 59 O.S. § 1332 by failing to return the defendant within ninety (90) days or pay the bond forfeiture within ninety-one (91) days from receipt of the Order and Judgment of Forfeiture or within the additional time period provided by the Pontotoc District Court.

ORDER

IT IS THEREFORE ORDERED that Raemona Perry shall pay the bond amount Three Hundred Dollars (\$300.00) to the Pontotoc County Court. This amount is to be paid within 30 days of the date of this Order.


Respondent is further notified that she may request a hearing within 30 days of the receipt of this Order concerning this action and upon such request the Insurance Department shall conduct a hearing before an independent hearing examiner. A request for hearing shall be made in writing to Kim M. Rytter, Oklahoma Insurance Department, Legal Division, 3625 NW 56th Suite 100, Oklahoma City, Oklahoma 73112 and state the basis for requesting the hearing.

If Respondents do not request a hearing within the 30 days allotted this Order shall be a **FINAL ORDER** on the 31st day following the receipt of the Order.
