CONSENT ORDER

COMES NOW the State of Oklahoma, ex rel. John D. Doak, Insurance Commissioner, and the Respondents Sherry Boyer and Ken Boyer, and enter into this Consent Order.

JURISDICTION

- 1. John D. Doak is the Oklahoma Insurance Commissioner, having full power and authority to administer the provisions of the Oklahoma Bail Bond Code, 59 O.S. §§1301-1340.
- 2. Sherry Boyer is a licensed surety bail bondsman in the State of Oklahoma holding license number 199834.
- 3. Ken Boyer is a licensed professional bail bondsman in the State of Oklahoma holding license number 199779.
- 4. Sherry Boyer and Ken Boyer have been apprised of their rights including the right to a public hearing and have knowingly and freely waived said rights and entered into this Consent Order as a voluntary settlement to the issues and questions raised in the above captioned case.

STIPULATIONS OF FACT

1. On or about July 7 2010, an appearance bond was executed as follows:

2. On or about September 1, 2010, the defendant failed to appear and the bond was declared forfeited. An Order and Judgment of Forfeiture was issued by the Court and filed in the case. A true and correct copy of the Order and Judgment of Forfeiture was mailed to Respondents within thirty (30) days after the date of the forfeiture.

- 3. Sherry Boyer received a copy of the Order and Judgment of Forfeiture on September 24, 2010. Ken Boyer received notice of the Order and Judgment of Forfeiture on September 24, 2010. The ninety-first (91st) day after receipt of the Order and Judgment of Forfeiture was December 27, 2010. Respondents failed to return defendant to custody within ninety (90) days of receipt of the Order and Judgment of Forfeiture. The sum of four thousand dollars (\$4,000.00) was deposited with the court clerk prior to the ninety first (91st) day; however, the remainder of the sum due was not deposited with the clerk prior to the ninety first (91st) day.
 - 4. The forfeiture was later paid on December 29, 2010.

CONCLUSIONS OF LAW

Sherry Boyer and Ken Boyer have violated 59 O.S. § 1332(D) by failing to deposit cash or other valuable securities in the face amount of the bond with the Court Clerk ninety-one (91) days from receipt or mailing of the Order and Judgment of Forfeiture from the Court Clerk.
