

FINDINGS

1. On or about March 11, 2010, an appearance bond was executed as follows:

Defendant:	Jerry Don O'Bleness
Case Number(s):	CM-2007-849
City/County:	Garfield
Bondsman:	Wilbur Leatherman
Surety:	Barry Tucker
Power Number(s):	790
Bond Amount(s):	\$3,000.00

2. On July 14, 2010, the Defendant failed to appear and the bond was declared forfeited.

An Order and Judgment of Forfeiture was issued by the district court on July 23, 2010, and filed in the case. A true and correct copy of the Order and Judgment of Forfeiture was mailed to Respondents with return receipt requested within thirty (30) days after the forfeiture.

3. Leatherman received a copy of the Order and Judgment of Forfeiture on July 29, 2010. Tucker received a copy of the Order and Judgment of Forfeiture but failed to date the return receipt.

4. The ninety-first (91st) day after receipt of the Order and Judgment of Forfeiture by Leatherman was October 28, 2010. The Defendant was not returned to custody within ninety (90) days of receipt of the Order and Judgment of Forfeiture, nor was sums due on the forfeiture deposited with the court clerk on the ninety first (91st) day.

5. The forfeiture was untimely paid on November 8, 2010. The Defendant was returned to custody on January 13, 2011, and the bond was exonerated on January 18, 2011.

CONCLUSIONS

The allegations are found to be true and correct and Respondents have violated 59 O.S. § 1332 by failing to return the defendant within ninety (90) days or pay the bond forfeiture within

ninety-one (91) days from receipt of the Order and Judgment of Forfeiture.

ORDER

IT IS THEREFORE ORDERED that Wilbur Leatherman and Barry Tucker are fined in the amount of Six Hundred Dollars (\$600.00) each. The fines are to be paid within 30 days of the date of this Order.



A request for hearing shall be made in writing to Kim M. If Respondents do not request a hearing within the 30 days allotted this Order shall be a **FINAL ORDER** on the 31st day following the receipt of the Order.

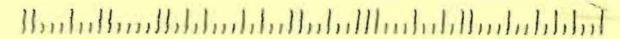
