

4. Respondents have been apprised of their rights including the right to a public hearing and have knowingly and freely waived said rights and entered into this Consent Order as a voluntary settlement to the issues and questions raised in the above captioned case.

STIPULATIONS OF FACT

1. On or about December 10, 2009, an appearance bond was executed as follows:

Defendant:	James Elbert Lee, Jr.
Case Number:	CF-08-362
Court:	Payne County District Court
Bondsman:	Jill Dillard
Surety:	United States Fire Insurance Company
Power Number:	2022B198
Bond Amount:	\$2,500.00

2. On or about August 17, 2010, the defendant failed to appear and the bond was declared forfeited. An Order and Judgment of Forfeiture was issued by the Court and filed in the case. A true and correct copy of the Order and Judgment of Forfeiture was mailed to Respondents within thirty (30) days after the date of the forfeiture.

3. The copy of the Order and Judgment of Forfeiture mailed to Jill Dillard was returned to the Court and marked "unclaimed" on September 8, 2010.

4. United States Fire Insurance Company received a copy of the Order and Judgment of Forfeiture on August 19, 2010.

5. The ninety-first (91st) day after receipt of the Order and Judgment of Forfeiture by United States Fire Insurance Company was November 18, 2010.

6. Respondents failed to return the defendant to custody within ninety (90) days of receipt of the Order and Judgment of Forfeiture and failed to remit the face amount of the forfeited bail bond to the Court by the ninety-first (91st) day.

7. Jill Dillard remitted payment of the face amount of the forfeited on January 24, 2011.

CONCLUSIONS OF LAW

Respondents have violated 59 O.S. § 1332(D) by failing to deposit cash or other valuable securities in the face amount of the bond with the Court Clerk ninety-one (91) days from receipt or mailing of the Order and Judgment of Forfeiture from the Court Clerk.

ORDER AND CONSENT

IT IS THEREFORE ORDERED by the Insurance Commissioner and CONSENTED to by Respondents that the Conditional Order Administrative Order and Notice of Right to be Heard entered on April 12, 2011 is vacated, Jill Dillard is CENSURED, and United States Fire Insurance Company is CENSURED.




