**CONDITIONAL ADMINISTRATIVE ORDER**  
**AND NOTICE OF RIGHT TO BE HEARD**

COMES NOW the State of Oklahoma, ex rel., John D. Doak, Insurance Commissioner, by and through counsel and alleges and states as follows:

**JURISDICTION**

- 1. John D. Doak is the Insurance Commissioner of the State of Oklahoma and as such is charged with the duty of administering and enforcing all provisions of the Oklahoma Insurance Code 36 O.S. §§ 101-7004 and the Oklahoma Bail Bond Act 59 O. S. §§ 1301-1340.
- 2. Respondent Stephen Mac Purvis (“Purvis”) is a licensed bail bondsman in the State of Oklahoma holding license number 200283.

**FINDINGS**

- 1. On or about December 2, 2009, an appearance bond was executed as follows:

Defendant:	Mandi Marie Morales
Case Number(s):	CF-09-633
City/County:	Bryan County
Bondsman:	Stephen Mac Purvis

Power Number(s): 6582  
Bond Amount(s): \$5,000.00

2. On August 19, 2010, the Defendant failed to appear, and the bond was declared forfeited. An Order and Judgment of Forfeiture was issued by the district court on August 23, 2010 and filed in the case. A true and correct copy of the Order and Judgment of Forfeiture was mailed to Respondents with return receipt requested within thirty (30) days after the forfeiture.

3. Purvis received a copy of the Order and Judgment of Forfeiture on September 13, 2010.

4. The ninety-first (91<sup>st</sup>) day after receipt of the Order and Judgment of Forfeiture by Respondent was December 13, 2010. The Defendant was not returned to custody within ninety (90) days of receipt of the Order and Judgment of Forfeiture.

5. As of the date of this *Conditional Administrative Order and Notice of Right to be Heard*, the forfeited bond remains unpaid.

#### **CONCLUSIONS OF LAW**

The allegations are found to be true and correct, and Respondent has violated 59 O.S. § 1332 by failing to return the defendant within ninety (90) days or remit payment in the face amount of the bond forfeiture within ninety-one (91) days from receipt of the Order and Judgment of Forfeiture.

#### **ORDER**

**IT IS THEREFORE ORDERED that Stephen Mac Purvis is fined One Thousand Dollars (\$1,000.00).**

Respondent is further notified that they may request a hearing within 30 days of the receipt of this Order concerning this action, and upon such request, the Oklahoma Insurance Department shall

conduct a hearing before an independent hearing examiner. A request for hearing shall be made in writing to Natasha M. Scott, Oklahoma Insurance Department, Legal Division, 3625 NW 56<sup>th</sup> Suite 100, Oklahoma City, Oklahoma 73112 and state the basis for requesting the hearing.

**If Respondent does not request a hearing within the 30 days allotted, this Order shall become a FINAL ORDER on the 31<sup>st</sup> day following the receipt of the Order, the fine ordered herein shall be due, and the face amount of the forfeited bond (\$5,000.00) shall be withdrawn from Respondent's deposit.**

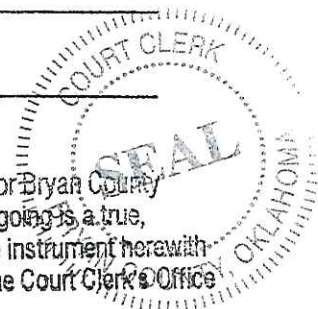

ORDER AND JUDGMENT OF FORFEITURE

On AUGUST 19, 2010, the above cause came on for hearing, according to regular assignment of the docket of this Court. The Court finds that the above named defendant having heretofore been charged with the crime of CT1 UNLAWFUL POSSESSION OF COCAINE W/INTENT TO DISTRIBUTE, CT2 POSS OF CS MAR, CT3 UNLAWFUL POSS OF DRUG PARAPHERNALIA, CT4 SPEEDING and having been committed to bail in the amount of \$ 5,000.00 , was released on an Appearance Bond executed by: STEPHEN MAC PURVIS, a licensed bondsman, and if applicable to his insurer PURVIS, STEPHEN; said bond conditioned as provided by law for the appearance of said Defendant before this Court as required, and the Court having ordered said Defendant to appear on AUGUST 19, 2010, and said Defendant, being called three times in open Court, without sufficient excuse, failed to appear before the Court as ordered.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the Court Clerk shall immediately mail a copy of this Order and Judgment of Forfeiture to the Bondsman and, if applicable, to his Insurer. The Bondsman is hereby directed to deposit with the Court Clerk, the face amount of the said forfeited bond.

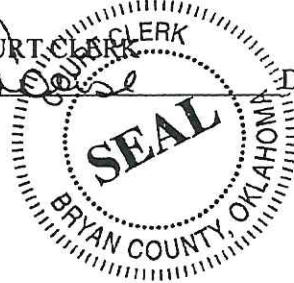

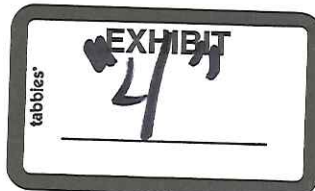
