

FINDINGS

1. On or about July 25, 2010, an appearance bond was executed as follows:

Defendant:	Jeremiah James Pratt
Case Number(s):	CM-09-602
City/County:	Payne County
Surety:	U.S. Fire Insurance Company
Bondsman:	James Manuel
Power Number(s):	U5-20278660
Bond Amount(s):	\$2,000.00

2. On September 15, 2010, the Defendant failed to appear, and the bond was declared forfeited. An Order and Judgment of Forfeiture was issued by the district court on September 15, 2010 and filed in the case. A true and correct copy of the Order and Judgment of Forfeiture was mailed to Respondents with return receipt requested within thirty (30) days after the forfeiture.

3. U.S. Fire received a copy of the Order and Judgment of Forfeiture on September 17, 2010.

4. Manuel received a copy of the Order and Judgment of Forfeiture on September 16, 2010.

5. The ninety-first (91st) day after receipt of the Order and Judgment of Forfeiture by Manuel was December 16, 2010. The Defendant was not returned to custody within ninety (90) days of receipt of the Order and Judgment of Forfeiture.

6. As of the date of this Conditional Order, the forfeited bail bond remains unpaid.

CONCLUSIONS OF LAW

The allegations are found to be true and correct, and Respondents have violated 59 O.S. § 1332 by failing to return the defendant within ninety (90) days or remit payment in the face amount of the bond forfeiture within ninety-one (91) days from receipt of the Order and Judgment of

Forfeiture.

ORDER

IT IS THEREFORE ORDERED that James Manuel and U.S. Fire Insurance Company are each fined Four Hundred Dollars (\$400.00).

Respondents are further notified that they may request a hearing within 30 days of the receipt of this Order concerning this action, and upon such request, the Oklahoma Insurance Department shall conduct a hearing before an independent hearing examiner. A request for hearing shall be made in writing to Natasha M. Scott, Oklahoma Insurance Department, Legal Division, 3625 NW 56th Suite 100, Oklahoma City, Oklahoma 73112 and state the basis for requesting the hearing.

If Respondents do not request a hearing within the 30 days allotted, this Order shall become a FINAL ORDER on the 31st day following the receipt of the Order, the face amount of the forfeited bail bond shall be deposited with the Payne County Court Clerk, and the fines ordered herein shall be due.

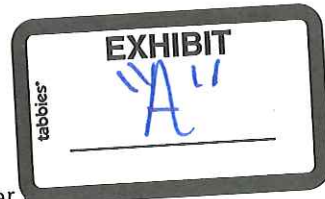

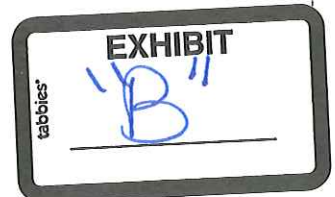

ORDER AND JUDGMENT OF FORFEITURE

On this 15th day of September, 2010, the above cause comes on for hearing, pursuant to regular assignment.

The court finds that the above-named defendant, having been charged in this case, and having been committed to bail in the amount of \$2,000.00, and having been on an appearance bond executed by **James Manuel**, a licensed bondsman, and **United States Fire Insurance Company**, the insurer; said bond conditioned as provided by law for the appearance of said defendant before this court as required, and the court having ordered said defendant to appear on the **24th day of August, 2010**, and said defendant failed to appear before the court as ordered.

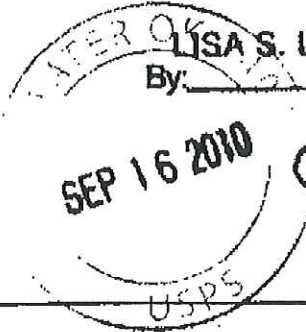

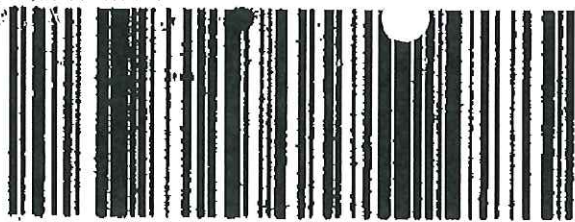
