CONDITIONAL ADMINISTRATIVE ORDER
AND NOTICE OF RIGHT TO BE HEARD

COMES NOW the State of Oklahoma, ex rel., John D. Doak, Insurance Commissioner, by
and through counsel and alleges and states as follows:

JURISDICTION

1. John D. Doak is the Insurance Commissioner of the State of Oklahoma and as such is
charged with the duty of administering and enforcing all provisions of the Oklahoma Insurance Code
36 O.S. §§ 101-7004 and the Oklahoma Bail Bond Act 59 O. S. §§ 1301-1340.

2. Respondent Jon England ("England") is a licensed professional bail bondsman in the
State of Oklahoma holding license number 199950.

3. Respondent Michael Cecil ("Cecil") is a licensed bail bondsman in the State of
Oklahoma holding license number 40084230.

FINDINGS

1. On or about August 10, 2010, an appearance bond was executed as follows:

Defendant: Bobby Lee Perkins
Case Number(s): 184310V
City/County: City of Moore Municipal Court
Bondsman: Jon England
Surety: Michael Cecil
Bond Amount(s): \$219.00

2. On June 2, 2010, the Defendant failed to appear, and the bond was declared forfeited. An Order and Judgment of Forfeiture was issued by the municipal court on June 2, 2010. A true and correct copy of the Order and Judgment of Forfeiture was mailed to Respondents with return receipt requested within thirty (30) days after the forfeiture.

3. England received a copy of the Order and Judgment of Forfeiture on June 8, 2010.

4. The copy of the Order and Judgment of Forfeiture mailed to Cecil was returned as unclaimed by the United States Post Office on June 19, 2010.

5. The ninety-first (91st) day after receipt of the Order and Judgment of Forfeiture by England was September 1, 2010. The Defendant was not returned to custody within ninety (90) days of receipt of the Order and Judgment of Forfeiture, nor were sums due on the forfeiture deposited with the court clerk on the ninety first (91st) day.

6. As of April 18, 2011, the forfeited bond remains unpaid.

CONCLUSIONS

The allegations are found to be true and correct and Respondents have violated 59 O.S. § 1332 by failing to return the defendant within ninety (90) days or payment of the bond forfeiture within ninety-one (91) days from receipt of the Order and Judgment of Forfeiture.

ORDER

IT IS THEREFORE ORDERED that Respondents are each fined in the amount of One

Hundred Dollars (\$100.00).

Respondents are further notified that he may request a hearing within 30 days of the receipt of this Order concerning this action and upon such request the Insurance Department shall conduct a hearing before an independent hearing examiner. A request for hearing shall be made in writing to Natasha M. Scott, Oklahoma Insurance Department, Legal Division, 3625 NW 56th Suite 100, Oklahoma City, Oklahoma 73112 and state the basis for requesting the hearing.

If Respondents do not request a hearing within the 30 days allotted, this Order shall be a FINAL ORDER on the 31st day following the receipt of the Order, the face amount of the forfeited bond (\$100.00) shall be withdrawn from the deposit of Jon England, and the fines ordered herein shall be due to the Oklahoma Insurance Department.
