



**FINDINGS**

1. On or about February 25, 2010, an appearance bond was executed as follows:

Defendant:	Chaderick Hendricks
Case Number(s):	5363764
City/County:	Tulsa Municipal Court
Bondsman:	Walter Armstrong
Surety:	Safety National Casualty Corporation
Power Number(s):	S5-18G2982
Bond Amount(s):	\$300.00

2. On June 25, 2010, the Defendant failed to appear, and the bond was declared forfeited. An Order and Judgment of Forfeiture was issued by the municipal court on June 25, 2010, and filed in the case. A true and correct copy of the Order and Judgment of Forfeiture was mailed to Respondents with return receipt requested within thirty (30) days after the forfeiture.

3. Armstrong received a copy of the Order and Judgment of Forfeiture on July 21, 2010. Safety National received a copy of the Order and Judgment of Forfeiture on July 13, 2010.

4. The ninety-first (91<sup>st</sup>) day after receipt of the Order and Judgment of Forfeiture by Armstrong was October 20, 2010. The Defendant was not returned to custody within ninety (90) days of receipt of the Order and Judgment of Forfeiture, nor was sums due on the forfeiture deposited with the court clerk on the ninety first (91<sup>st</sup>) day.

5. The forfeiture was untimely paid.

**CONCLUSIONS**

The allegations are found to be true and correc, and Respondents have violated 59 O.S. § 1332 by failing to return the defendant within ninety (90) days or pay the bond forfeiture within ninety-one (91) days from receipt of the Order and Judgment of Forfeiture.

**ORDER**

**IT IS THEREFORE ORDERED that Walter Armstrong and Safety National Casualty Corporation are CENSURED.**

Respondents are further notified that they may request a hearing within 30 days of the receipt of this Order concerning this action and upon such request the Insurance Department shall conduct a hearing before an independent hearing examiner. A request for hearing shall be made in writing to Natasha M. Scott, Oklahoma Insurance Department, Legal Division, 3625 N.W. 56<sup>th</sup> Street, Suite 100, Oklahoma City, Oklahoma 73112. The request shall state the basis for requesting the hearing.

If Respondents do not request a hearing within the 30 days allotted this Order shall be a **FINAL ORDER** on the 31<sup>st</sup> day following the receipt of the Order.



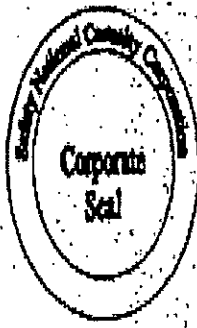


