CONDITIONAL ADMINISTRATIVE ORDER AND NOTICE OF RIGHT TO BE HEARD

COMES NOW the State of Oklahoma, ex rel., John D. Doak, Insurance Commissioner, by and through counsel and alleges and states as follows:

JURISDICTION

- 1. John D. Doak is the Insurance Commissioner of the State of Oklahoma and as such is charged with the duty of administering and enforcing all provisions of the Oklahoma Insurance Code 36 O.S. §§ 101-7004 and the Oklahoma Bail Bond Act 59 O. S. §§ 1301-1340.
- 2. Steven Gandy ("Respondent") is a licensed bail bondsman in the State of Oklahoma holding license number 199360.

FINDINGS OF FACTS

- 1. Respondent's bail bond license is registered in Stephens County, Oklahoma.
- 2. On or about December 8, 2010, the office of the Jefferson County Court Clerk informed the Oklahoma Insurance Department ("Department") that Respondent had written bail bonds in Jefferson County on more than ten (10) defendants between October 1, 2010 and November 23, 2010. (Exhibit "A").

3. The bail bonds written in Jefferson County by Respondent during this period are attached hereto and marked Exhibit "B" and are as follows:

4. Other licensed bail bondsmen were registered in Jefferson County at the time.

CONCLUSION OF LAW

Respondent acted in violation of 59 O.S. § 1320(B), which prohibits a bondsman from writing bonds on more than ten (10) defendants per year in counties where the bondsman cannot register his license. Respondent has also violated 365:25-5-38 of the Oklahoma Administrative Code, which provides as follows:

Pursuant to 59 O.S. § 1320, a bondsman is authorized to write bonds on up to ten defendants per year, October 1 through September 30, in each county outside his resident county. For purpose of determining

the ten defendants, the bondsman shall consider each date a bond or bonds are written on a defendant as being one of the ten defendants, not withstanding any previous bonds which have been written on that same individual. The ten defendant limit does not apply in counties without a registered bondsman in said county.

OKLA. ADMIN. CODE § 365:25-5-38.

ORDER

IT IS THEREFORE ORDERED that Respondent is fined in the amount of Two Hundred Fifty Dollars (\$250.00).

Respondent is further notified that he may request a hearing within 30 days of the receipt of this Order concerning this action, and upon such request, the Insurance Department shall conduct a hearing before an independent hearing examiner. A request for hearing shall be made in writing to Natasha M. Scott, Oklahoma Insurance Department, Legal Division, 3625 NW 56th Suite 100, Oklahoma City, Oklahoma 73112 and state the basis for requesting the hearing. Such written request shall include an explanation of Respondent's actions described herein and any defenses thereof.

If Respondent does not request a hearing within the 30 days allotted, this Order shall be a FINAL ORDER on the 31st day following the receipt of the Order, and the fine ordered herein shall be due to the Oklahoma Insurance Department.


