#### FINAL ADMINISTRATIVE ORDER

INSURANCE COMMISSIONER

ON the 24<sup>th</sup> day of March, 2011, the above captioned case came on for hearing and was concluded on the same date. The Insurance Commissioner, John D. Doak, was represented by his attorney, Julie Meaders. Respondent Halie Nicole Callaway was present, having been mailed a copy of the Notice of Hearing by certified mail with return receipt requested, pursuant to the Oklahoma Producer Licensing Act, 36 O.S. § 1435.1 et seq. and the Oklahoma Administrative Procedures Act, 75 O.S. § 250 et seq. The Hearing Examiner, having been fully advised in the premises, finds as follows:

# **JURISDICTION AND AUTHORITY**

1. The Insurance Commissioner has jurisdiction over this cause, pursuant to the provisions of the Oklahoma Producer Licensing Act, 36 O.S. § 1435.1 et seq.

### **FINDINGS OF FACT**

- 1. On or about the 25<sup>th</sup> day of February, the Oklahoma Licensing Division, through Licensing Manager, Leah Scoles, caused to be mailed to Callaway a letter denying her application for licensure.
- 2. On or about the 9<sup>th</sup> day of March, 2011, Callaway requested an administrative hearing on the matter.

- 3. The Insurance Commissioner appointed Leamon Freeman to hear the case as the independent Hearing Examiner.
- 4. The Hearing was recorded electronically by employees of the Oklahoma Insurance Department. Neither party requested a full stenographic record of the proceedings.
  - 5. The following exhibits were introduced and admitted without objection:

Petitioner's Exhibit 1: Callaway's provisional application for licensure.

Petitioner's Exhibit 2: Callaway's producer application for licensure.

Petitioner's Exhibit, 3: Sircon document showing status of both applications.

Petitioner's Exhibit 4: Sircon profile for Halie Callaway.

Petitioner's Exhibit 5: Cherokee county docket sheet for CM-09-553.

Petitioner's Exhibit 6: Cherokee county docket sheet for CM-10-47.

Respondent's Exhibit 1: Letter from Cherokee County District Attorney.

- 6. Callaway and Leah Scoles were sworn and testified under oath.
- 7. The Hearing Examiner heard testimony and entered the following findings of fact:
- a. Callaway submitted a provisional application with her name spelled Hallie Callaway. Provisional license was granted due to clear background check with this name spelling.
- b. Callaway submitted her producer application with her name spelled Halie Callaway. License was denied pursuant to 36 O.S. § 1435.13(A)(1) due to a finding of undisclosed criminal history under this spelling of her name.
  - c. Callaway requested a hearing as was her right pursuant to 36 O.S. § 1435.13(B).
- d. Callaway testified that an addiction to prescription pain pills resulted in the criminal charges against her. Testimony was further presented to the Hearing Examiner that Callaway had

successfully completed rehabilitation caused by her addiction.

8. Callaway's application is granted on the condition that she is to be placed on probation and monitored until renewal of her license in two (2) years.


#### **CONCLUSIONS OF LAW**

- 1. These proceedings were conducted pursuant to the applicable provisions of the Oklahoma Administrative Procedures Act, 75 O.S. §§ 250 et seq., and the Oklahoma Producer Licensing Act, 36 O.S. § 1435.1 et seq.
- 2. The Commissioner has jurisdiction to conduct this hearing as Respondent applied for a producer license pursuant to 36 O.S. 1435.13.
- 3. Neither party requested a stenographic record of the proceedings but an electronic recording of the proceedings was made by an employee of the Oklahoma Insurance Department's office.
  - 6. 36 O.S. § 1435.13 is discretionary as to whether a license may be issued.
- 7. Respondent's application is granted on the condition that she is to be placed on probation and monitored until renewal of her license in two (2) years.

#### **ORDER**

IT IS THEREFORE ORDERED that State's denial of Respondent's application for a producer license in the State of Oklahoma is overruled.
