CONDITIONAL ADMINISTRATIVE ORDER
AND NOTICE OF RIGHT TO BE HEARD

COMES NOW the State of Oklahoma, ex rel., John D. Doak, Insurance Commissioner, by and through counsel and alleges and states as follows:

JURISDICTION

1. John D. Doak is the Insurance Commissioner of the State of Oklahoma and as such is charged with the duty of administering and enforcing all provisions of the Oklahoma Insurance Code 36 O.S. §§ 101-7004 and the Oklahoma Bail Bond Act 59 O. S. §§ 1301-1340.
2. Respondent Connie Manuel (“Manuel”) is a licensed bail bondsman in the State of Oklahoma holding license number 199425.
3. Respondent Eddie Ray Inman (“Inman”) is a licensed professional bail bondsman in the State of Oklahoma holding license number 94365.

FINDINGS

1. On or about October 11, 2010, appearance bonds were executed as follows:

Defendant: Mickos Holmes

Case Number(s):	CM-2010-1567
City/County:	Payne County
Bondsman:	Connie Manuel
Insurer:	Eddie Ray Inman
Power Number(s):	A3139
Bond Amount(s):	\$1,000.00

2. On December 20, 2010, the Defendant failed to appear, and the bond was declared forfeited. An Order and Judgment of Forfeiture was issued by the district court on December 20, 2010, and filed in the case. A true and correct copy of the Order and Judgment of Forfeiture was mailed to Respondents with return receipt requested within thirty (30) days after the forfeiture.

3. Manuel received a copy of the Order and Judgment of Forfeiture on December 21, 2010.

4. Inman received a copy of the Order and Judgment of Forfeiture on December 21, 2010.

5. The ninety-first (91st) day after receipt of the Order and Judgment of Forfeiture by Manuel was March 22, 2011. The Defendant was not returned to custody within ninety (90) days of receipt of the Order and Judgment of Forfeiture, nor were sums due on the forfeiture deposited with the court clerk on the ninety-first (91st) day.

6. The forfeited bail bond was paid on April 4, 2011.

CONCLUSIONS

The allegations are found to be true and correct, and Respondents have violated 59 O.S. § 1332 by failing to return the defendant within ninety (90) days or to make payment of the bond forfeiture within ninety-one (91) days from receipt of the Order and Judgment of Forfeiture.

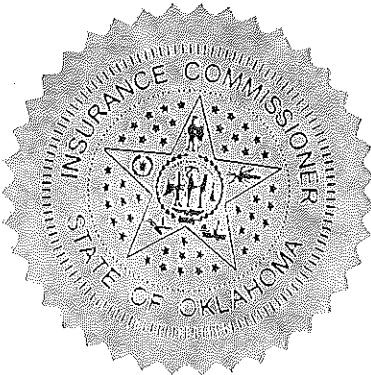
ORDER

IT IS THEREFORE ORDERED that Respondents are each fined in the amount of Two Hundred Fifty Dollars (\$250.00).

Respondents are further notified that a hearing may be requested within 30 days of the receipt of this Order concerning this action and upon such request the Insurance Department shall conduct a hearing before an independent hearing examiner. A request for hearing shall be made in writing to Natasha M. Scott, Oklahoma Insurance Department, Legal Division, 3625 NW 56th Suite 100, Oklahoma City, Oklahoma 73112 and state the basis for requesting the hearing.

If Respondents do not request a hearing within the 30 days allotted, this Order shall be a FINAL ORDER on the 31st day following the receipt of the Order, and the fines ordered herein shall be due to the Oklahoma Insurance Department.



ORDER AND JUDGMENT OF FORFEITURE

On this 20th day of December, 2010, the above cause comes on for hearing, pursuant to regular assignment.

The court finds that the above-named defendant, having been charged in this case, and having been committed to bail in the amount of \$1,000.00, and having been on an appearance bond executed by Connie Manuel, a licensed bondsman, and Eddie Inman, the insurer; said bond conditioned as provided by law for the appearance of said defendant before this court as required, and the court having ordered said defendant to appear on the 30th day of November, 2010, and said defendant failed to appear before the court as ordered.

The court further finds that said bondsman had due and legal notice as provided by law of the required appearance of said defendant. 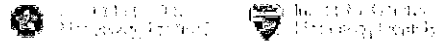
