AND NOTICE OF RIGHT TO BE HEARD

COMES NOW the State of Oklahoma, ex rel., John D. Doak, Insurance Commissioner, by and through counsel and alleges and states as follows:

JURISDICTION

- 1. John D. Doak is the Insurance Commissioner of the State of Oklahoma and as such is charged with the duty of administering and enforcing all provisions of the Oklahoma Insurance Code 36 O.S. §§ 101-7004 and the Oklahoma Bail Bond Act 59 O. S. §§ 1301-1340.
- 2. Respondent Connie Manuel ("Manuel") is a licensed bail bondsman in the State of Oklahoma holding license number 199425.
- 3. Respondent Eddie Ray Inman ("Inman") is a licensed professional bail bondsman in the State of Oklahoma holding license number 94365.

FINDINGS

1. On or about October 11, 2010, appearance bonds were executed as follows:

2. On December 20, 2010, the Defendant failed to appear, and the bond was declared forfeited. An Order and Judgment of Forfeiture was issued by the district court on December 20, 2010, and filed in the case. A true and correct copy of the Order and Judgment of Forfeiture was mailed to Respondents with return receipt requested within thirty (30) days after the forfeiture.

- Manuel received a copy of the Order and Judgment of Forfeiture on December 21,
 2010.
- 4. Inman received a copy of the Order and Judgment of Forfeiture on December 21, 2010.
- 5. The ninety-first (91st) day after receipt of the Order and Judgment of Forfeiture by Manuel was March 22, 2011. The Defendant was not returned to custody within ninety (90) days of receipt of the Order and Judgment of Forfeiture, nor were sums due on the forfeiture deposited with the court clerk on the ninety-first (91st) day.
 - 6. The forfeited bail bond was paid on April 4, 2011.

CONCLUSIONS

The allegations are found to be true and correct, and Respondents have violated 59 O.S. § 1332 by failing to return the defendant within ninety (90) days or to make payment of the bond forfeiture within ninety-one (91) days from receipt of the Order and Judgment of Forfeiture.

ORDER

IT IS THEREFORE ORDERED that Respondents are <u>each</u> fined in the amount of Two Hundred Fifty Dollars (\$250.00).




