CONDITIONAL ADMINISTRATIVE ORDER
AND NOTICE OF RIGHT TO BE HEARD

COMES NOW the State of Oklahoma, ex rel., John D. Doak, Insurance Commissioner, by and through counsel and alleges and states as follows:

JURISDICTION

1. John D. Doak is the Insurance Commissioner of the State of Oklahoma and as such is charged with the duty of administering and enforcing all provisions of the Oklahoma Insurance Code 36 O.S. §§ 101-7004 and the Oklahoma Bail Bond Act 59 O. S. §§ 1301-1340.

2. Respondent Stacy French (“French”) is a licensed bail bondsman in the State of Oklahoma holding license number 40087375.

3. Respondent Safety National Casualty Corporation (“Safety National”) is an admitted insurance company in the State of Oklahoma holding NAIC number 15105.

FINDINGS

1. On or about January 13, 2011, an appearance bond was executed as follows:

2. On February 24, 2011, the Defendant failed to appear, and the bond was declared forfeited. An Order and Judgment of Forfeiture was issued by the Bethany Municipal Court on February 24, 2011, and filed in the case. A true and correct copy of the Order and Judgment of Forfeiture was mailed to Respondents with return receipt requested within thirty (30) days after the forfeiture.

3. French received a copy of the Order and Judgment of Forfeiture on March 5, 2011 as evidenced by the United States Postal Service electronic confirmation of delivery.

4. Safety National received a copy of the Order and Judgment of Forfeiture on March 8, 2011.

5. The ninety-first (91st) day after receipt of the Order and Judgment of Forfeiture by French was June 4, 2011; however, that date occurred on a Saturday. Thus, the ninety-first (91st) day became Monday, June 6, 2011. The Defendant was not returned to custody within ninety (90) days of receipt of the Order and Judgment of Forfeiture, nor were sums due on the forfeiture deposited with the court clerk on the ninety-first (91st) day.

6. On June 7, 2011, the Bethany Municipal Court received check number 2957 from Johnson's Bail Bond Services, Inc. in the amount of \$1,666.00. Case number CR-2010-4119, the case in which the forfeiture occurred, is written on the check. The check was returned to the Bethany Municipal Court by the bank upon which it was drawn and marked "RETURN REASON – A NOT

SUFFICIENT FUNDS.”

7. To date, the face amount of the forfeited bail bond remains unpaid.

CONCLUSIONS

The allegations are found to be true and correct, and Respondents have violated 59 O.S. § 1332 by failing to return the defendant within ninety (90) days or payment of the bond forfeiture within ninety-one (91) days from receipt of the Order and Judgment of Forfeiture.

ORDER

IT IS THEREFORE ORDERED that Respondents are each fined in the amount of Three Hundred Thirty Dollars (\$330.00).

Respondents are further notified that he may request a hearing within 30 days of the receipt of this Order concerning this action and upon such request the Insurance Department shall conduct a hearing before an independent hearing examiner. A request for hearing shall be made in writing to Natasha M. Scott, Oklahoma Insurance Department, Legal Division, 3625 NW 56th Suite 100, Oklahoma City, Oklahoma 73112 and state the basis for requesting the hearing.

If Respondents do not request a hearing within the 30 days allotted, this Order shall be a FINAL ORDER on the 31st day following the receipt of the Order, and the fines ordered herein shall be due to the Oklahoma Insurance Department.

ORDER AND JUDGMENT OF FORFEITURE

On February 24, 2011 @ 8:30 am , the above cause came on for hearing, according to regular assignment of the docket of this Court.

The Court finds that the above-named defendant having heretofore been charged with the crime(s) of Driving under suspension, Failure to wear seatbelt/adult, No proof of insurance, Failure to appear, and having been committed to bail in the amount of 1666.00, was released on an Appearance Bond executed by Stacy French, a licensed bondsman, and Safety National Casualty Corporation, said bond conditioned as provided by law for the appearance of said defendant before this court as required, and the Court having ordered said defendant to appear on the February 24, 2011 @ 8:30 am , and said defendant, being called three times in open court, without sufficient excuse, failed to appear before the Court as ordered.

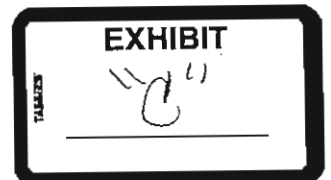

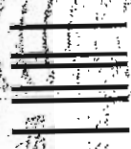
