**CONDITIONAL ADMINISTRATIVE ORDER
AND NOTICE OF RIGHT TO BE HEARD**

JURISDICTION

1. John D. Doak is the Insurance Commissioner of the State of Oklahoma and as such is charged with the duty of administering and enforcing all provisions of the Oklahoma Insurance Code 36 O.S. §§ 101-7004 and the Oklahoma Bail Bond Act 59 O.S. §§ 1301-1340.

2. Respondent Diana Baldwin (“Baldwin”) is a licensed bail bondsman in the State of Oklahoma holding license number 200183.

3. Respondent Roxana Sellars (“Sellars”) is a licensed professional bail bondsman in the State of Oklahoma holding license number 200184.

FINDINGS

1. On or about December 19, 2010, an appearance bond was executed as follows:

Defendant: Sonya Pruitt
Case Number(s): CM-2011-101
City/County: Tulsa County
Insurer: Roxana Sellars
Bondsman: Diana Baldwin
Power Number(s): 7282
Bond Amount(s): \$250.00

2. On March 29, 2011, the Defendant failed to appear in the case, and the bond was declared forfeited. An Order and Judgment of Forfeiture was issued by the district court on April 1, 2011, and filed in the case. A true and correct copy of the Order and Judgment of Forfeiture was mailed to the Respondents with return receipt requested within thirty (30) days after the forfeiture.

3. Both Sellars and Baldwin received a copy of the Order and Judgment of Forfeiture on April 6, 2011.

4. The ninety-first (91st) day after receipt of the Orders and Judgments of Forfeiture was July 6, 2011.

5. The Defendant was not returned to custody within ninety (90) days of receipt of the Orders and Judgments of Forfeiture nor was the face amount of the forfeited bail bond paid to the court clerk on the ninety-first (91st) day.

6. The forfeited bond was untimely paid on July 20, 2011.

CONCLUSIONS OF LAW

The allegations are found to be true and correct, and Respondents have violated 59 O.S. § 1332 by failing to return the defendant within ninety (90) days or remit payment in the face amounts of the bail bond forfeitures within ninety-one (91) days from receipt of the Order and Judgment of Forfeiture.

ORDER

IT IS THEREFORE ORDERED that Diana Baldwin and Roxana Sellars are each CENSURED.

Respondents are further notified that they may request a hearing within 30 days of the receipt of this Order concerning this action, and upon such request, the Oklahoma Insurance Department shall conduct a hearing before an independent hearing examiner. A request for hearing shall be made in writing to Natasha M. Scott, Oklahoma Insurance Department, Legal Division, 3625 NW 56th Suite 100, Oklahoma City, Oklahoma 73112 and state the basis for requesting the hearing.

If Respondents do not request a hearing within the 30 days allotted, this Order shall become a FINAL ORDER on the 31st day following the receipt of the Order.

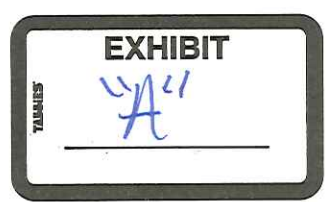

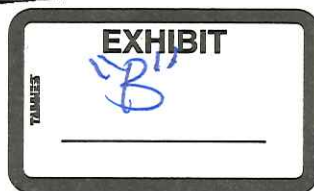

The Court finds that the above named defendant having heretofore been charged with the crime of: **POSSESSION OF DRUG PARAPHERNALIA** having been committed to bail in the amount shown below and released on an appearance bond executed by the bondsman, and if applicable his insurer, as shown below:
