2. On March 14, 2011, the Defendant failed to appear in each case, and the bonds were declared forfeited. An Order and Judgment of Forfeiture was issued by the municipal court in each case on March 22, 2011, and filed in each case. True and correct copies of the Orders and Judgments of Forfeiture were mailed to Respondents with return receipt requested within thirty (30) days after the forfeiture.

3. Bates received copies of the Orders and Judgments of Forfeiture on March 28, 2011.

4. Merrill also received copies of the Orders and Judgments of Forfeiture on March 28, 2011.

5. The ninety-first (91st) day after receipt of the Orders and Judgments of Forfeiture was June 27, 2011.

6. The Defendant was not returned to custody within ninety (90) days of receipt of the Orders and Judgments of Forfeiture nor were the face amounts of the forfeited bail bonds paid to the court clerk on the ninety-first (91st) day.

7. The forfeited bonds remain unpaid to date.

CONCLUSIONS OF LAW

The allegations are found to be true and correct, and Respondents have violated 59 O.S. § 1332 by failing to return the defendant within ninety (90) days or remit payment in the face amounts of the bail bond forfeitures within ninety-one (91) days from

receipt of the Orders and Judgments of Forfeiture.

ORDER

IT IS THEREFORE ORDERED that Gregory Bates and Raymond Merrill are each fined Two Hundred Fifty Dollars (\$250.00).

Respondents are further notified that they may request a hearing within 30 days of the receipt of this Order concerning this action, and upon such request, the Oklahoma Insurance Department shall conduct a hearing before an independent hearing examiner. A request for hearing shall be made in writing to Natasha M. Scott, Oklahoma Insurance Department, Legal Division, 3625 NW 56th Suite 100, Oklahoma City, Oklahoma 73112 and state the basis for requesting the hearing.

If Respondents do not request a hearing within the 30 days allotted, this Order shall become a FINAL ORDER on the 31st day following the receipt of the Order, the fines ordered herein shall be due to the Oklahoma Insurance Department, and the face amounts of the forfeited bail bonds shall be withdrawn from the deposit of Raymond Merrill.
