CONDITIONAL ADMINISTRATIVE ORDER AND NOTICE OF RIGHT TO BE HEARD

COMES NOW the State of Oklahoma, ex rel., John D. Doak, Insurance Commissioner, by and through counsel and alleges and states as follows:

JURISDICTION

- 1. John D. Doak is the Insurance Commissioner of the State of Oklahoma and as such is charged with the duty of administering and enforcing all provisions of the Oklahoma Insurance Code 36 O.S. §§ 101-7004 and the Oklahoma Bail Bond Act 59 O. S. §§ 1301-1340.
- 2. Terry Horton is a licensed bail bondsman in the State of Oklahoma holding license number 199282.

FINDINGS

Monthly Surety Bondsman Reports

- 1. In November 2001, Terry Horton ("Respondent") became licensed as both a cash and a surety bail bondsman. In December 2006, Respondent was appointed by American Contractors Indemnity Company to execute bail bonds as a surety of the company.
 - 2. On March 2, 2011, the Oklahoma Insurance Department ("Department") mailed a

letter to the Respondent, via certified mail, informing him that his January 2011 Monthly Surety Bondsman Report ("surety report") had not been received. The report was due February 15, 2011. The letter was received by the Respondent on March 3, 2011. The letter stated that the surety report was to be received by March 15, 2011. (Exhibit "A").

- 3. The Department did not receive the Respondent's January 2011 surety report until March 29, 2011. The envelope in which the report was mailed was postmarked March 25, 2011. (Exhibit "B").
- 4. On March 21, 2011, the Department received the Respondent's February 2011 surety report, which was due March 15, 2011. The envelope in which the report was mailed was postmarked March 16, 2011. (Exhibit "C").
- 5. On April 25, 2011, the Department received the Respondent's March 2011 surety report, which was due April 15, 2011. The envelope in which the report was mailed was postmarked April 21, 2011. (Exhibit "D").
- 6. On May 5, 2011, the Department mailed a letter to the Respondent, via certified mail, acknowledging the receipt and untimely filing of his March 2011 surety report. The letter also informed the Respondent that he had untimely filed his surety reports for the previous three (3) months and warned that if this pattern continued, the matter would be referred to the Department's Legal Division for administrative action. The letter also stated that the beginning liability on the March 2011 surety report needed to be corrected. (Exhibit "E"). The Respondent received the letter on May 6, 2011.
- 7. On June 24, 2011, the Department received the Respondent's May 2011 surety report, which was due June 15, 2011. (Exhibit "F"). The envelope in which the report was mailed was not

postmarked.

- 8. On August 1, 2011, the Department received the Respondent's June 2011 surety report, which was due July 15, 2011. (Exhibit "G"). The envelope in which the report was mailed was not postmarked.
- 9. On August 16, 2011, the Department mailed the Respondent a letter, via certified mail, acknowledging the receipt and untimely filing of his June 2011 surety report. The letter also informed the Respondent that he had untimely filed his surety reports for the previous five (5) months and that the untimely filings had been referred to the Department's Legal Division for administrative action. (Exhibit "H").

Monthly Cash Bondsman Reports

- 10. On March 29, 2011, the Department received the Respondent's January 2011 Monthly Cash Bondsman Report ("cash report"), which was due February 15, 2011. (Exhibit "I"). The envelope in which the report was mailed was postmarked March 25, 2011. (Exhibit "B").
- 11. On March 21, 2011, the Department received the Respondent's February 2011 cash report, which was due March 15, 2011. (Exhibit "J"). The envelope in which the report was mailed was postmarked March 16, 2011. (Exhibit "C").
- 12. On April 25, 2011, the Department received the Respondent's March 2011 cash report, which was due April 15, 2011. (Exhibit "K"). The envelope in which the report was mailed was postmarked April 21, 2011. (Exhibit "D").
- 13. On August 1, 2011, the Department received the Respondent's May 2011 and June 2011 cash reports, which were due June 15, 2011 and July 15, 2011, respectively. (Exhibits "L" and "M"). The envelope in which the reports were mailed had no postmark.

CONCLUSIONS

The above described conduct of the Respondent is in violation of the Oklahoma Bail Bond Act and the Oklahoma Administrative Code. Section 1314 of the Oklahoma Bail Bond Act requires that every licensed bondsman file monthly reports by mail with return receipt requested. The monthly reports must be submitted to the Insurance Commissioner "within fifteen (15) days after the end of each preceding month pursuant to 59 O.S. § 1314." OKLA. ADMIN. CODE 365:25-5-36(a). "Monthly reports shall be postmarked or stamped "received" by the Insurance Commissioner by the fifteenth day of each month." OKLA. STAT. tit. 59 O.S., § 1314(B) (2010). "Bondsmen must submit a monthly report for each surety company with which he/she is appointed, whether or not any bonds were written on that company during that month" OKLA. ADMIN. CODE 365:25-5-36(b)(1). "All bondsmen must submit a report for each component of the license held, even if no bonds were written under any particular component during that month. The types of licenses include: (1) cash, (2) surety . . ." OKLA. ADMIN. CODE 365:25-5-36(a).

ORDER

IT IS THEREFORE ORDERED that the Respondent is hereby FINED in the amount of Two Hundred Fifty Dollars (\$250.00) for the conduct described herein.

The Respondent is further notified that a hearing may be requested within thirty (30) days of the receipt of this Order concerning this action and upon such request the Insurance Department shall conduct a hearing before an independent hearing examiner. A request for hearing shall be made in writing to Natasha M. Scott, Oklahoma Insurance Department, Legal Division, 3625 NW 56th Suite 100, Oklahoma City, Oklahoma 73112 and shall state the basis for requesting the hearing.

If the Respondent does not request a hearing within the thirty (30) days allotted, this

Order shall be a FINAL ORDER on the 31st day following the receipt of the Order, and the

fine ordered herein shall be due.
