 - 3. The thirtieth (30th) day after the date of the inquiry was August 12th 2011.
 - 4. The Department did not receive a response within 30 days.
- 5. Respondent's undersigned representative has the authority to execute this Consent Order and has had the opportunity to consult with legal counsel.
- 6. In entering this Consent Order, Respondent does not admit any liability or fault. Although Respondent disputes the above Stipulations of Fact, to resolve this matter, Respondent accepts the Stipulations of Fact as true for the purposes of entering this Consent Order.

ORDER AND CONSENT

IT IS THEREFORE ORDERED by the Insurance Commissioner and CONSENTED to by Respondent that Respondent shall pay a settlement fine in the amount of Five Hundred Dollars (\$500.00) to settle the issues and questions in the above captioned case.
