**CONDITIONAL ADMINISTRATIVE ORDER**  
**AND NOTICE OF RIGHT TO BE HEARD**

COMES NOW the State of Oklahoma, ex rel., John D. Doak, Insurance Commissioner, by and through counsel and alleges and states as follows:

**JURISDICTION**

1. John D. Doak is the Insurance Commissioner of the State of Oklahoma and as such is charged with the duty of administering and enforcing all provisions of the Oklahoma Insurance Code 36 O.S. §§ 101-7004 and the Oklahoma Bail Bond Act 59 O. S. §§ 1301-1340.

2. Respondent Curtis Pletcher (“Pletcher”) is a licensed professional bail bondsman in the State of Oklahoma holding license number 199574.

3. Respondent Chauncey Summers (“Summers”) is a licensed bail bondsman in the State of Oklahoma holding license number 40041039.

1. On or about March 30, 2011, six appearance bonds were executed as follows:

Defendant:	Kevin R. Keizor

Bondsman:	Chauncey Summers
Surety:	Curtis Pletcher

Bond Amount(s):	\$200.00; \$200.00; \$500.00; \$100.00; \$500.00; \$150.00

2. On May 24, 2011, the Defendant failed to appear, and the bonds were declared forfeited. An Orders and Judgments of Forfeiture were issued by the municipal court on May 24, 2011, and filed in the cases. True and correct copies of the Orders and Judgments of Forfeiture were mailed to Respondents with return receipts requested within thirty (30) days after the forfeitures.

3. Pletcher received a copy of the Order and Judgment of Forfeiture on June 13, 2011.

4. Summers received a copy of the Order and Judgment of Forfeiture on June 11, 2011.

5. The ninety-first (91<sup>st</sup>) day after receipt of the Order and Judgment of Forfeiture by Summers was September 10, 2011. That date occurred on a Saturday; thus, the ninety-first (91<sup>st</sup>) day became Monday, September 12, 2011. The Defendant was not returned to custody within ninety (90) days of receipt of the Order and Judgment of Forfeiture, nor were sums due on the forfeiture deposited with the court clerk on the ninety first (91<sup>st</sup>) day.

### CONCLUSIONS

The allegations are found to be true and correct and Respondents have violated 59 O.S. § 1332 by failing to return the defendant within ninety (90) days or payment of the bond forfeiture within ninety-one (91) days from receipt of the Order and Judgment of Forfeiture.

### ORDER

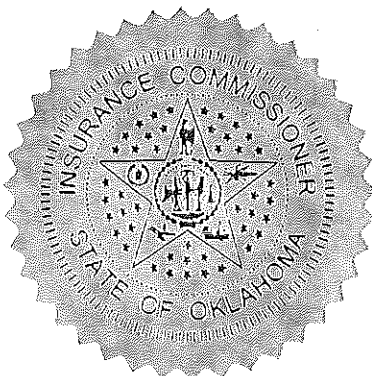
**IT IS THEREFORE ORDERED that Respondents are each fined in the amount of Three Hundred Thirty Dollars (\$330.00).**

Respondents are further notified that he may request a hearing within 30 days of the receipt of

this Order concerning this action and upon such request the Insurance Department shall conduct a hearing before an independent hearing examiner. A request for hearing shall be made in writing to Natasha M. Scott, Oklahoma Insurance Department, Legal Division, 3625 NW 56<sup>th</sup> Suite 100, Oklahoma City, Oklahoma 73112 and shall state the basis for requesting the hearing.

**If Respondents do not request a hearing within the 30 days allotted this Order shall be a FINAL ORDER on the 31<sup>st</sup> day following the receipt of the Order, the fines ordered herein shall be due to the Oklahoma Insurance Department, and the face amounts of the forfeited bonds shall be withdrawn from the professional deposit of Respondent Curtis Pletcher.**
