**ORDER**

COMES NOW the State of Oklahoma, ex rel. John D. Doak, Insurance Commissioner (“Petitioner”), by and through Assistant General Counsel, Michael P. Copeland, and hereby states the following:

On March 13, 2012, a *Conditional Administrative Order and Notice of Right to be Heard* (“Order”) was issued against Respondent and mailed to Respondent via certified mail with return receipt requested on the same date. Respondent’s license was conditionally suspended because he failed to pay a fine to the Commissioner, levied for failing to timely remit payment of the bond forfeiture in Oklahoma County case number CF-2010-7979. Respondent received the Order on March 20, 2012.

Respondent paid the fine due on April 6, 2012. .

IT IS THEREFORE ORDERED, ADJUDGED, AND DECREED that the *Conditional*

*Administrative Order Notice of Right to be Heard* issued against Respondent on March 13, 2012  
is hereby vacated.


