



2. On December 13, 2011, Respondent filed with the Insurance Commissioner a paper surety report for the month of November, 2011, but failed to file an electronic monthly report with the Commissioner, as required by 59 O.S. § 1314(B).

3. On January 3, 2012, Respondent filed with the Insurance Commissioner a paper surety report for the month of December, 2011, but failed to file an electronic monthly report with the Commissioner, as required by 59 O.S. § 1314(B).

### CONCLUSIONS OF LAW

The allegations are found to be true and correct, and Respondent has violated 59 O.S. § 1314(B) by failing to file his monthly reports electronically with the Insurance Commissioner.

### ORDER

**IT IS THEREFORE ORDERED that John A. Ives, Jr. is fined Two Hundred Fifty Dollars (\$250.00).**



A request for hearing shall be made in writing to Michael P.
