# CONDITIONAL ADMINISTRATIVE ORDER AND NOTICE OF RIGHT TO BE HEARD

**COMES NOW** the State of Oklahoma, ex rel. John D. Doak, Insurance Commissioner, by and through his attorney, Julie Meaders, and alleges and states as follows:

### **JURISDICTION**

- 1. John D. Doak is the Insurance Commissioner of the State of Oklahoma and is charged with the duty of administering and enforcing all provisions of the Oklahoma Insurance Code, 36 O.S. §§ 101 et seq.
- Jerry Chris Flowers is a licensed resident insurance adjuster holding license
   81274. His address of record is 2004 Thunderbird Boulevard, Edmond, Oklahoma 73013.
- 3. The Insurance Commissioner may censure, suspend, revoke or refuse to issue a renewal license issued pursuant to the Oklahoma Insurance Adjusters Licensing Act and/or may levy a fine up to \$1,000.00 for each occurrence of a violation of the Oklahoma Insurance Code 36 O.S. § 6220.

#### ALLEGATIONS OF FACT

- 1. Respondent submitted an application for an adjuster license on July 5, 2011. The application stated that Respondent has never been named or involved as a party in an administrative proceeding regarding any professional or occupational license or registration.
- 2. Respondent declared under penalty of perjury that the statements made in the application were true, correct and complete.
- 3. Oklahoma Insurance Department records reveal that Respondent entered into a Consent Order with the Oklahoma Insurance Department and paid a \$1,000.00 fine in Case 01-0445-DIS for issuing a fraudulent insurance verification card while licensed as a producer with the same license number 81274.
- 4. Respondent failed to disclose this administrative action when he applied for an adjuster license in 2011.

## **CONCLUSIONS OF LAW**

1. Respondent violated 36 O.S. § 6220(A)(1) for material misrepresentation in obtaining his adjuster's license by failing to disclose his previous administrative action with the Oklahoma Insurance Department.

#### **ORDER**

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED by the Insurance Commissioner, subject to the following paragraph, that the Respondent violated 36 O.S. § 6220(A)(1) and as a result Respondent is FINED in the amount of FIVE HUNDRED DOLLARS (\$500.00). Fine to be paid within thirty (30) days of receipt of this Order.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED by the Insurance Commissioner that this Order is a Conditional Order. Unless the Respondent requests a hearing

with respect to the Allegations of Fact set forth above within thirty (30) days of the date of mailing of this Order, this Order and the penalties set forth above shall become a Final Order on the thirty-first day following the date of mailing this Order. A request for hearing should be in writing addressed to Julie Meaders, Oklahoma Insurance Department, Legal Division, 3625 NW 56<sup>th</sup> Street, Suite 100, Oklahoma City, Oklahoma 73112. The request for hearing must state the grounds for the request to set aside or modify the Order.

Any such hearing shall be conducted according to the procedures for contested cases under the Insurance Code and 75 O.S. § 250-323. If the Respondent serves a timely request for hearing on the Oklahoma Insurance Department, this Conditional Order shall act as notice of the matters to be reviewed at the hearing, and the Allegations of Fact, Alleged Violations of Law, and penalties imposed in this Conditional Order shall be considered withdrawn, pending final resolution at the hearing.
