CONDITIONAL ORDER DISALLOWING DISCLAIMER OF INTEREST AND NOTICE OF RIGHT TO BE HEARD

COMES NOW the State of Oklahoma, ex rel. John D. Doak, Insurance Commissioner, and issues this Conditional Order Disallowing Disclaimer of Interest as to AccessCare General Oklahoma LLC, a prospective Domestic Oklahoma Pre-Paid Dental Insurer ("the Prospective Domestic Insurer"), and the person seeking a disclaimer of interest therein, William Schifman ("Mr. Schifman"), based upon the following:

JURISDICTION

1. John D. Doak is the Insurance Commissioner of the State of Oklahoma and as such is charged with the duty of administering and enforcing all provisions of the Oklahoma Insurance Code, 36 O.S. §§ 101 et seq. Under 36 O.S. §§ 1651 and 1654 (i), the Insurance Commissioner has the authority to review and allow or disallow requests for disclaimers of interest as a "control person" as that term is defined and used in 36 O.S. § 1651. Under this Section of the Oklahoma Insurance Code, a person or entity is deemed to have presumptive "control" of an Oklahoma domestic insurer if it owns, directly or indirectly, 10% or more of such insurer.

- 2. The Prospective Domestic Insurer seeks to become an Oklahoma domestic prepaid dental insurer.
- 3. The Prospective Domestic Insurer is a wholly-owned subsidiary of HDCI, LCC, and thereby is part of an insurance holding company system.

FINDINGS OF FACT

- 1. On or about December 15, 2011, Mr. Schifman submitted a written request with supporting information requesting a disclaimer of control of the Prospective Domestic Insurer. Mr. Schifman owns 15.5% of the Prospective Domestic Insurer. He is also described as the Managing Director of the Prospective Domestic Insurer.
- 2. Based on these facts and the requirements of 36 O.S. §§ 1654 (i), Mr. Schifman meets the presumption of a control person and cannot disclaim such affiliation with the Prospective Domestic Insurer.

CONCLUSIONS OF LAW

- 1. John D. Doak is the Insurance Commissioner of the State of Oklahoma and as such is charged with the duty of administering and enforcing all provisions of the Oklahoma Insurance Code, 36 O.S. §§ 101 et seq. Under 36 O.S. §§ 1651 and 1654 (i), the Insurance Commissioner has the authority to review and allow or disallow requests for disclaimers of interest as a "control person" as that term is defined and used in 36 O.S. § 1651. Under this Section of the Oklahoma Insurance Code, a person or entity is deemed to have presumption of "control" of an Oklahoma domestic insurer if it owns, directly or indirectly, 10% or more of such insurer.
- 2. The burden of proof is on the person or entity disclaiming control. O.A.C. 365:25-7-29(e).

- 3. Mr. Schifman owns more than 10% of the Prospective Oklahoma Domestic Insurer and is described as its Managing Director. These facts taken together invoke the presumption of control under Oklahoma law.
- 4. Therefore, Mr. Schifman's request for a disclaimer of control or affiliation is denied.

ORDER

IT IS THEREFORE ORDERED that the request for disclaimer of affiliation with the Prospective Domestic Insurer, AccessCare General Oklahoma LLC, made by Mr. Schifman, is denied.

IT IS FURTHER ORDERED that the above denial shall become immediately effective unless within thirty (30) days from receipt of this Conditional Order AccessCare General Oklahoma LLC or any person or entity seeking to disclaim control thereof, requests in writing a hearing on the matter. If no hearing is requested, the Order denying disclaimer becomes effective at the end of said thirty (30) day period without further action by the Oklahoma Insurance Department.
