

FINDINGS

CF-2010-206 (12-0222-DIS)

1. On or about February 21, 2010, an appearance bond was executed as follows:

Defendant:	Jason Patrick Nunez
Case Number(s):	CF-2010-206
City/County:	Canadian County
Surety:	Safety National Casualty Corporation
Bondsman:	Candise Adcock
Power Number(s):	S5-1870837
Bond Amount(s):	\$2,000.00

2. On August 15, 2011, the Defendant failed to appear and the bond was declared forfeited. An Order and Judgment of Forfeiture was issued by the court on August 17, 2011 and filed in the case. A true and correct copy of the Order and Judgment of Forfeiture was mailed to Respondents with return receipt requested within thirty (30) days after the forfeiture.

3. Adcock received a copy of the Order and Judgment of Forfeiture on August 19, 2011.

4. Safety National received a copy of the Order and Judgment of Forfeiture on August 22, 2011.

5. The ninety-first (91st) day after receipt of the Order and Judgment of Forfeiture by Respondents was November 18, 2011.

6. On November 17, 2011, Adcock filed a motion to stay execution of the bond forfeiture for 30 days. A stay was granted until December 19, 2011.

7. On December 19, 2011, Adcock filed a motion to stay execution of the bond forfeiture for 30 days. A stay was granted until January 19, 2012.

8. On January 19, 2012, Adcock filed a motion to stay execution of the bond forfeiture for 30 days. A stay was granted until February 21, 2012. The Defendant was not returned to custody

within this time, nor was deposit in the face amount of the bail bond made to the court clerk. No further stay was granted.

9. On March 1, 2012, Safety National deposited with the court clerk the face amount of the forfeited bond.

TR-2010-1916 (12-0223-DIS)

10. On or about February 21, 2010, an appearance bond was executed as follows:

11. On August 15, 2011, the Defendant failed to appear and the bond was declared forfeited. An Order and Judgment of Forfeiture was issued by the court on August 17, 2011 and filed in the case. A true and correct copy of the Order and Judgment of Forfeiture was mailed to Respondents with return receipt requested within thirty (30) days after the forfeiture.

12. Adcock received a copy of the Order and Judgment of Forfeiture on August 18, 2011.

13. Safety National received a copy of the Order and Judgment of Forfeiture on August 22, 2011.

14. The ninety-first (91st) day after receipt of the Order and Judgment of Forfeiture by Respondents was November 17, 2011.

15. On November 17, 2011, Adcock filed a motion to stay execution of the bond forfeiture for 30 days. A stay was granted until January 19, 2012.

16. On January 19, 2012, Adcock filed a motion to stay execution of the bond forfeiture

for 30 days. A stay was granted until February 21, 2012. The Defendant was not returned to custody within this time, nor was deposit in the face amount of the bail bond made to the court clerk. No further stay was granted.

17. On March 1, 2012, Safety National deposited with the court clerk the face amount of the forfeited bond.

CONCLUSIONS OF LAW

The allegations are found to be true and correct, and Respondents have violated 59 O.S. § 1332 by failing to return the defendant within ninety (90) days or remit payment in the face amount of the bond forfeitures within ninety-one (91) days from receipt of the Order and Judgment of Forfeiture. Under 59 O.S. § 1310(B), any person or entity violating a provision of the Bail Bond Act may be subject to a civil penalty ranging from \$250 to \$2,500.

ORDER

IT IS THEREFORE ORDERED that Candise Adcock and Safety National are each fined Two Hundred Sixty Dollars (\$260.00).

Respondents are further notified that they may request a hearing within 30 days of the receipt of this Order concerning this action, and upon such request, the Oklahoma Insurance Department shall conduct a hearing before an independent hearing examiner in accordance with the Bail Bond Code, OKLA. STAT. tit. 59, §§ 1301 et seq., and the Oklahoma Administrative Procedures Act, OKLA. STAT. tit. 75, §§ 301 et seq. A request for hearing shall be made in writing to Michael P. Copeland, Oklahoma Insurance Department, Legal Division, 3625 NW 56th Suite 100, Oklahoma City, Oklahoma 73112 and **give an explanation of Respondents' actions described herein and any defenses thereto.**

If Respondents do not request a hearing within the 30 days allotted, this Order shall become a FINAL ORDER on the 31st day following the receipt of the Order and the fines ordered herein shall be due.


