

FINDINGS

1. On or about May 28, 2011, an appearance bond was executed as follows:

Defendant:	Arlondo Maurice Carr
Case Number(s):	329161; 329161A; 329161B
City/County:	Tulsa Municipal
Surety:	Curtis Pletcher
Bondsman:	Chauncey Summers
Power Number(s):	28595; 28596; 28597
Bond Amount(s):	\$150; \$200; \$750

2. On August 3, 2011, the Defendant failed to appear, and the bonds were declared forfeited. An Order and Judgment of Forfeiture was issued by the court for each separate count on December 14, 2011, and filed in the cases. A true and correct copy of each Order and Judgment of Forfeiture was mailed to Respondents with return receipt requested within thirty (30) days after the forfeiture.

3. Summers received a copy of the Order and Judgment of Forfeiture on August 25, 2011.

4. Pletcher received a copy of the Order and Judgment of Forfeiture on August 15, 2011.

5. The ninety-first (91st) day after receipt of the Order and Judgment of Forfeiture by Respondents was Friday, November 25, 2011. Because that day was a holiday, the forfeiture was due on Monday, November 28, 2011. The Defendant was not returned to custody nor was the face amount of the forfeited bond deposited with the Court Clerk on November 28.

6. As of the date of this Conditional Order, the forfeited bail bond remains unpaid.

CONCLUSIONS OF LAW

1. The allegations are found to be true and correct, and Respondents have violated 59

O.S. § 1332 by failing to return the Defendant within ninety (90) days or remit payment in the face amount of the bond forfeiture within ninety-one (91) days from receipt of the Order and Judgment of Forfeiture.

2. Pursuant to 59 O.S. § 1310(B), any bondsman violating a provision of the Bail Bond Act, 59 O.S. §§ 1301-1340, may be subject to a civil penalty ranging from \$250 to \$2,500.

ORDER

IT IS THEREFORE ORDERED that Chauncey Summers and Curtis Pletcher are each fined Two Hundred Fifty Dollars (\$250.00).

IT IS FURTHER ORDERED that the face amount of the forfeited bonds (\$1,100 total) shall be withdrawn from Curtis Pletcher's professional bondsman deposit held by the Insurance Commissioner and deposited with the Tulsa Municipal Court Clerk, unless the bond forfeiture is paid before this Order becomes final.

Respondents are further notified that they may request a hearing within 30 days of the receipt of this Order concerning this action, and upon such request, the Oklahoma Insurance Department shall conduct a hearing before an independent hearing examiner. A request for hearing shall be made in writing to Michael P. Copeland, Oklahoma Insurance Department, Legal Division, 3625 NW 56th Suite 100, Oklahoma City, Oklahoma 73112 and **give an explanation of Respondents' actions alleged herein and any defenses thereto.**

If Respondents do not request a hearing within the 30 days allotted, this Order shall become a FINAL ORDER on the 31st day following the receipt of the Order, the face amount of the forfeited bail bond shall be withdrawn from the professional deposit of Curtis Pletcher and deposited with the Tulsa Municipal Court Clerk, and the fines ordered

herein shall be due.


