**CONDITIONAL ADMINISTRATIVE ORDER
AND NOTICE OF RIGHT TO BE HEARD**

COMES NOW the State of Oklahoma, ex rel. John D. Doak, Insurance Commissioner, by and through counsel and alleges and states as follows:

JURISDICTION

1. John D. Doak is the Insurance Commissioner of the State of Oklahoma and as such is charged with the duty of administering and enforcing all provisions of the Oklahoma Insurance Code, 36 O.S. §§ 101-7301, and the Oklahoma Bail Bond Act, 59 O. S. §§ 1301-1340.
2. Respondent Michael Bradshaw (“Bradshaw”) is a licensed bail bondsman in the State of Oklahoma holding license number 40096678.
3. Respondent Bonnie Galmor (“Galmor”) is a licensed professional bail bondsman in the State of Oklahoma holding license number 200305.

FINDINGS

1. On or about February 10, 2012, an appearance bond was executed as follows:

Defendant: Demarco Diontae White

Case Number(s):	CM-2011-1958
City/County:	Cleveland County
Surety:	Bonnie Galmor
Bondsman:	Michael Bradshaw
Power Number(s):	B25-0006020
Bond Amount(s):	\$2500

2. On February 16, 2012, the Defendant failed to appear, and the bond was declared forfeited. An Order and Judgment of Forfeiture was issued by the court on March 13, 2012, and filed in the case. A true and correct copy of the Order and Judgment of Forfeiture was mailed to Respondents with return receipt requested within thirty (30) days after the forfeiture.

3. Bradshaw received a copy of the Order and Judgment of Forfeiture on March 14, 2012.

4. Galmor received a copy of the Order and Judgment of Forfeiture on March 14, 2012.

5. The ninety-first (91st) day after receipt of the Order and Judgment of Forfeiture by Respondents was Wednesday, June 13, 2012.

6. Bail bondsman Eugene Phillips paid the bond forfeiture late on June 21, 2012. Phillips' check to the Cleveland County Court Clerk in the amount of \$2,500, dated June 21, 2012, was returned to the court as insufficient funds.

7. The Defendant was not returned to custody within 90 days, nor was the face amount of the forfeited bond deposited with the Court Clerk within 91 days of receipt of the Order and Judgment of Forfeiture.

8. As of the date of this Conditional Order, the forfeited bail bond has not been paid or otherwise set aside or exonerated.

CONCLUSIONS OF LAW

1. The allegations are found to be true and correct, and Respondents have violated 59 O.S. § 1332 by failing to return the Defendant within ninety (90) days or remit payment in the face amount of the bond forfeiture within ninety-one (91) days from receipt of the Order and Judgment of Forfeiture.

2. Pursuant to 59 O.S. § 1310(B), any bondsman violating a provision of the Bail Bond Act may be subject to a civil penalty ranging from \$250 to \$2,500.

ORDER

IT IS THEREFORE ORDERED that Michael Bradshaw and Bonnie Galmor are each FINED Two Hundred Fifty Dollars (\$250.00).

IT IS FURTHER ORDERED that pursuant 59 O.S. § 1332 the face amount of the bond, Two Thousand Five Hundred Dollars (\$2,500.00), shall be withdrawn from the deposit placed with the State of Oklahoma by Bonnie Galmor as reserve to meet sums due on forfeiture. The sums withdrawn are to be forwarded to the Cleveland County Court Clerk for payment of the bonds in case number CM-2011-1958, Defendant Demarco Diontae White. Such sums shall not be withdrawn from the deposit of Bonnie Galmor if the bond forfeiture is paid or otherwise set aside within 30 days of receipt of this Order.

Respondents are further notified that they may request a hearing within 30 days of the receipt of this Order concerning this action, and upon such request, the Oklahoma Insurance Department shall conduct a hearing before an independent hearing examiner. A request for hearing shall be made in writing to William G. "Buddy" Combs, Oklahoma Insurance Department, Legal Division, 3625 NW 56th Suite 100, Oklahoma City, Oklahoma 73112 and **give an explanation of Respondents'**

actions alleged herein and any defenses thereto.

If Respondents do not request a hearing within the 30 days allotted, this Order shall become a FINAL ORDER on the 31st day following the receipt of the Order, the face amount of the bond forfeiture shall be withdrawn from Bonnie Galmor's professional deposit and forwarded to the Cleveland County Court Clerk, and the fines ordered herein shall be due.

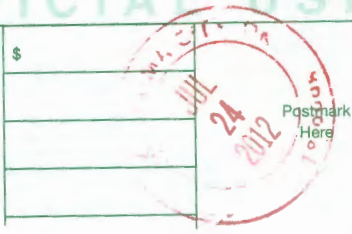
