**CONDITIONAL ADMINISTRATIVE ORDER
AND NOTICE OF RIGHT TO BE HEARD**

COMES NOW the State of Oklahoma, ex rel. John D. Doak, Insurance Commissioner, by and through counsel and alleges and states as follows:

JURISDICTION

1. John D. Doak is the Insurance Commissioner of the State of Oklahoma and as such is charged with the duty of administering and enforcing all provisions of the Oklahoma Insurance Code, 36 O.S. §§ 101-7301, and the Oklahoma Bail Bond Act, 59 O. S. §§ 1301-1340.

2. Jill Dillard (“Respondent”) is a licensed bail bondsman in the State of Oklahoma holding license number 40069514.

FINDINGS OF FACT

1. On June 15, 2012, Respondent submitted two insufficient electronic funds transfers (“EFT”) to the Oklahoma Insurance Department (“the Department”) in the amounts of \$77.18 (May 2012 Roche Surety and Casualty Company (“RSCC”) report) and \$3.00 (May 2012 RSCC Amended).

2. On July 12, 2012, the Department sent emails and mailed letters to Respondent, via

certified mail, informing Respondent of the unpaid amounts and informing her that a \$25.00 service fee was being assessed on each insufficient EFT. The letters also instructed that \$102.18 and \$28.00 (for the amount of the EFTs and \$25.00 for each service fee), for a total of \$130.18, be paid to the Department by cashier's check or money order within five (5) days of receipt of the letters.

3. Respondent failed to respond to the emails and both letters were returned to the Department marked "Unable to Forward." The letters were mailed to Respondent's address on file with the Department.

CONCLUSION OF LAW

1. Respondent acted in violation of 59 O.S. § 1310(A)(27) by uttering insufficient funds to the Insurance Commissioner.

2. Respondent acted in violation of 59 O.S. § 13010(A)(21) by failing to respond to a properly mailed notification within a reasonable amount of time.

ORDER

IT IS THEREFORE ORDERED that Jill Dillard is CENSURED and FINED Two Hundred Fifty Dollars (\$250.00), due and payable to the Oklahoma Insurance Department.

IT IS FURTHER ORDERED that Jill Dillard shall pay the full amount of her reviewal fees and service fees owed for the above listed reports in the amount of \$130.18 within 30 days of receipt of this Order. Failure to do so shall result in the SUSPENSION of Jill Dillard's license on the thirty-first (31st) day following receipt of this Order or the proper mailing of this Order if no receipt is made.

Respondent is further notified that she may request a hearing within 30 days of the receipt of this Order concerning this action, and upon such request, the Insurance Department shall conduct a

hearing before an independent hearing examiner in accordance with the Bail Bond Code, OKLA. STAT. tit. 59, §§ 1301 et seq., and the Oklahoma Administrative Procedures Act, OKLA. STAT. tit. 75, §§ 301 et seq. A request for hearing shall be made in writing to William G. “Buddy” Combs, Oklahoma Insurance Department, Legal Division, 3625 NW 56th Suite 100, Oklahoma City, Oklahoma 73112. **Such written request shall include an explanation of Respondent’s actions described herein and any defenses thereof.**


IT IS FURTHER ORDERED that this Order constitutes disciplinary action and may be used in any subsequent hearings by the Insurance Department. In the event other misconduct is reported to the Department, this Order may be used as evidence against Respondent to establish a pattern of behavior and for the purpose of proving additional acts of misconduct.

If Respondent does not request a hearing within the 30 days allotted, this Order shall be a FINAL ORDER on the 31st day following the receipt of the Order.

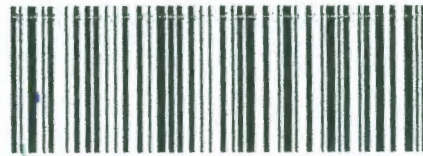
