CONDITIONAL ADMINISTRATIVE ORDER AND NOTICE OF RIGHT TO BE HEARD

COMES NOW the State of Oklahoma, ex rel. John D. Doak, Insurance Commissioner, by and through counsel and alleges and states as follows:

JURISDICTION

- 1. John D. Doak is the Insurance Commissioner of the State of Oklahoma and as such is charged with the duty of administering and enforcing all provisions of the Oklahoma Insurance Code, 36 O.S. §§ 101-7301, and the Oklahoma Bail Bond Act, 59 O. S. §§ 1301-1340.
- 2. Respondent Diana Teague ("Teague") is a licensed bail bondsman in the State of Oklahoma holding license number 199113.
- 3. Respondent Curtis Pletcher ("Pletcher") is a licensed professional bail bondsman in the State of Oklahoma holding license number 199574.

FINDINGS OF FACT

1. On or about December 4, 2011, two appearance bonds were executed as follows:

2. On April 20, 2012, the Defendant failed to appear, and the bonds were declared

forfeited. An Order and Judgment of Forfeiture was issued by the court for each case on April 26,

2012, and filed in the case. A true and correct copy of the Order and Judgment of Forfeiture was

mailed to Respondents with return receipt requested within thirty (30) days after the forfeiture.

3. Teague received a copy of the Order and Judgment of Forfeiture on May 3, 2012.

4. Pletcher received a copy of the Order and Judgment of Forfeiture on May 1, 2012.

The ninety-first (91st) day after receipt of the Order and Judgment of Forfeiture by 5.

Respondents was Thursday, August 2, 2012. The Defendant was not returned to custody within 90

days, nor was the face amount of the forfeited bond deposited with the Court Clerk within 91 days of

receipt of the Order and Judgment of Forfeiture.

As of the date of this Order, the bonds have not been paid or otherwise set aside or 6.

exonerated.

CONCLUSIONS OF LAW

1. The allegations are found to be true and correct, and Respondents have violated 59

O.S. § 1332 by failing to return the Defendant within ninety (90) days or remit payment in the face

amount of the bond forfeiture within ninety-one (91) days from receipt of the Order and Judgment of

Forfeiture.

2. Pursuant to 59 O.S. § 1310(B), any bondsman violating a provision of the Bail Bond

Act may be subject to a civil penalty ranging from \$250 to \$2,500.

<u>ORDER</u>

IT IS THEREFORE ORDERED that Diana Teague and Curtis Pletcher are <u>each</u> FINED Two Hundred Fifty Dollars (\$250.00), due and payable to the Oklahoma Insurance Department.

IT IS FURTHER ORDERED that pursuant 59 O.S. § 1332 the face amount of the bonds, Five Hundred Dollars (\$500.00), shall be withdrawn from the deposit placed with the State of Oklahoma by Curtis Pletcher as reserve to meet sums due on forfeiture. The sums withdrawn are to be forwarded to the Tulsa Municipal Court Clerk for payment of the bond in case numbers 345729% and 345729B, Defendant Neal James Roughface. Such sums shall not be withdrawn from the deposit of Curtis Pletcher if the bond forfeitures are paid or otherwise set aside within 30 days of receipt of this Order.

Respondents are further notified that they may request a hearing within 30 days of the receipt of this Order concerning this action, and upon such request, the Oklahoma Insurance Department shall conduct a hearing before an independent hearing examiner. A request for hearing shall be made in writing to William G. "Buddy" Combs, Oklahoma Insurance Department, Legal Division, 3625 NW 56th Suite 100, Oklahoma City, Oklahoma 73112 and give an explanation of Respondents' actions alleged herein and any defenses thereto.

If Respondents do not request a hearing within the 30 days allotted, this Order shall become a FINAL ORDER on the 31st day following the receipt of the Order, the face amount of the bond forfeitures shall be withdrawn from Curtis Pletcher's professional deposit and

forwarded to the Tulsa Municipal Court Clerk, and the fines ordered herein shall be due.
