# CONDITIONAL ADMINISTRATIVE ORDER AND NOTICE OF RIGHT TO BE HEARD

COMES NOW the State of Oklahoma, ex rel. John D. Doak, Insurance Commissioner, by and through counsel and alleges and states as follows:

### **JURISDICTION**

- 1. John D. Doak is the Insurance Commissioner of the State of Oklahoma and as such is charged with the duty of administering and enforcing all provisions of the Oklahoma Insurance Code, 36 O.S. §§ 101-7301, and the Oklahoma Bail Bond Act, 59 O. S. §§ 1301-1340.
- 2. Christopher Collier ("Respondent") is a licensed bail bondsman in the State of Oklahoma holding license number 40164942.

#### FINDINGS OF FACT

- On July 26, 2012, Respondent submitted to the Oklahoma Insurance Department ("Department") his June 2012 Allegheny Casualty Company report.
- 2. With this report, Respondent submitted an Electronic Funds Transfer ("EFT") of \$3.00. The Oklahoma State Treasurer charged the EFT back to the Department as "Insufficient

#### Funds."

- 3. On September 12, 2012, Department staff sent Respondent an email and a letter, via certified mail, requesting that the funds be replaced and a service fee of \$25.00 be paid within five days of receipt of the letter. Respondent signed for the letter on September 21, 2012.
- 4. As of the date of this Order, Respondent has not replaced the funds or responded to the Department.

#### **CONCLUSIONS OF LAW**

- 1. Respondent has violated 59 O.S. § 1310(A)(27) by uttering insufficient funds to the Commissioner.
- 2. Respondent has violated 59 O.S. § 1310(A)(21) by failing to respond to a properly mailed notification within a reasonable amount of time.

#### **ORDER**

IT IS THEREFORE ORDERED that Christopher Collier is CENSURED and FINED Two Hundred Fifty Dollars (\$250.00).

Respondent is further notified that he may request a hearing within 30 days of the receipt of this Order concerning this action and upon such request the Oklahoma Insurance Department shall conduct a hearing before an independent hearing examiner. A request for hearing shall be made in writing to Buddy Combs, Oklahoma Insurance Department, Legal Division, 3625 NW 56<sup>th</sup> Suite 100, Oklahoma City, Oklahoma 73112 and give an explanation of Respondent's actions described herein and any defenses thereto. If Respondent does not request a hearing within the 30 days allotted, this Order shall become a FINAL ORDER on the 31<sup>st</sup> day following

the receipt of the Order, and the fine ordered herein shall be due.
