CONDITIONAL ADMINISTRATIVE ORDER AND NOTICE OF RIGHT TO BE HEARD

COMES NOW the State of Oklahoma, ex rel. John D. Doak, Insurance Commissioner, by and through counsel and alleges and states as follows:

JURISDICTION

- 1. John D. Doak is the Insurance Commissioner of the State of Oklahoma and as such is charged with the duty of administering and enforcing all provisions of the Oklahoma Insurance Code, 36 O.S. §§ 101-7301, and the Oklahoma Bail Bond Act, 59 O.S. §§ 1301-1340.
- 2. Billy Wayne Dismuke ("Respondent") is a licensed surety bail bondsman in the State of Oklahoma holding license number 144708.

FINDINGS OF FACT

- 1. Respondent has been a licensed surety bail bondsman in Oklahoma since August 24, 1995. Respondent has never been approved by the Commissioner for the cash line of authority.
 - 2. On February 21, 2013, Respondent executed a cash bond for Defendant

Gregory Givens, a/k/a Gregory Poe, in Oklahoma County case CF-2012-4947, in the amount of \$2,000.

- 3. The cash bond was written on a "Jail Bail" form (attached as Exhibit "A"), which did not indicate the premium charged for the bond.
 - 4. Respondent did not submit with the cash bond an affidavit as to undertaking.

CONCLUSIONS OF LAW

- 1. Respondent has violated 59 O.S. §§ 1303 and 1310(A)(2) by executing a cash bond in Oklahoma County without a valid cash bondsman license.
- 2. Respondent has violated 59 O.S. § 1316(B) by failing to list on the bond the premium received.
- 3. Respondent has violated 59 O.S. § 1322(A) by failing to submit with the bond an affidavit as to undertaking.

ORDER

IT IS THEREFORE ORDERED that Billy Dismuke is FINED Two Hundred Fifty Dollars (\$250.00).

Respondent is notified that he may request a hearing within 30 days of the receipt of this Order concerning this action and upon such request the Oklahoma Insurance Department shall conduct a hearing before an independent hearing examiner. A request for hearing shall be made in writing to Buddy Combs, Oklahoma Insurance Department, Legal Division, 3625 NW 56th Suite 100, Oklahoma City, Oklahoma 73112 and give an explanation of Respondent's actions described herein and any defenses thereto.

If Respondent fails to request a hearing within 30 days of receipt of this Order, this

Order shall become a **FINAL ORDER** on the 31st day following the receipt of the Order.
