



**FINDINGS OF FACT**

1. On or about November 11, 2012, an appearance bond was executed as follows:

Defendant:	William Christopher Goree
Case Number(s):	114568383
City/County:	Oklahoma City Municipal
Surety:	Curtis Pletcher
Bondsman:	Charles Coleman
Power Number(s):	40710
Bond Amount(s):	\$167

2. On December 14, 2012, the Defendant failed to appear, and the bond was orally declared forfeited. An Order and Judgment of Forfeiture was issued by the court on December 31, 2012, and filed in the case. A true and correct copy of the Order and Judgment of Forfeiture was mailed to Respondents with return receipt requested within thirty (30) days after the forfeiture.

3. Coleman received a copy of the Order and Judgment of Forfeiture on January 3, 2013.

4. The mailing of the Order and Judgment of Forfeiture to Pletcher was returned to the Oklahoma City Municipal Court Clerk.

5. The ninety-first (91<sup>st</sup>) day after receipt of the Order and Judgment of Forfeiture by Respondents was Thursday, April 4, 2013. The Defendant was not returned to custody within 90 days, nor was the face amount of the bond forfeiture deposited with the Court Clerk on the 91<sup>st</sup> day after receipt of the Order and Judgment of Forfeiture.

6. As of the date of this Order, the bond forfeiture has not been paid or otherwise set aside and the bond exonerated.

**CONCLUSIONS OF LAW**

1. The allegations are found to be true and correct, and Respondents have violated 59 O.S. § 1332 by failing to return the Defendant within ninety (90) days or remit payment in the face amount of the bond forfeiture within ninety-one (91) days from receipt of the Order and Judgment of Forfeiture.

**ORDER**

**IT IS THEREFORE ORDERED that Charles Coleman and Curtis Pletcher are each CENSURED.**

**IT IS FURTHER ORDERED that pursuant 59 O.S. § 1332 the face amount of the bond, One Hundred Sixty-Seven Dollars (\$167.00), shall be withdrawn from the deposit placed with the State of Oklahoma by Curtis Pletcher as reserve to meet sums due on forfeiture. The sums withdrawn are to be forwarded to the Oklahoma City Municipal Court Clerk for payment of the bond in case number 114568383, Defendant William Christopher Goree. Such sums shall not be withdrawn from the deposit of Curtis Pletcher if the bond forfeiture is paid or otherwise set aside within 30 days of receipt of this Order.**


Respondents are further notified that they may request a hearing within 30 days of the receipt of this Order concerning this action, and upon such request, the Oklahoma Insurance Department shall conduct a hearing before an independent hearing examiner. A request for hearing shall be made in writing to William G. "Buddy" Combs, Oklahoma Insurance Department, Legal Division, 3625 NW 56<sup>th</sup> Suite 100, Oklahoma City, Oklahoma 73112 and **give an explanation of Respondents' actions alleged herein and any defenses thereto.**

If Respondents do not request a hearing within the 30 days allotted, this Order shall become a FINAL ORDER on the 31<sup>st</sup> day following the receipt of the Order and the face amount of the bond forfeiture shall be withdrawn from Curtis Pletcher's professional deposit and forwarded to the Oklahoma City Municipal Court Clerk.


