2. On March 5, 2013, the Defendant failed to appear, and the bonds were declared forfeited. On March 13, 2013, an Order and Judgment of Forfeiture was issued by the court and filed in the case. A true and correct copy of the Order and Judgment of Forfeiture was mailed to Respondents with return receipt requested within thirty (30) days after the Order's filing.

3. Burton received a copy of the Order and Judgment of Forfeiture on March 18, 2013.

4. Davis received a copy of the Order and Judgment of Forfeiture on March 19, 2013.

5. The ninety-first (91st) day after receipt of the Order and Judgment of Forfeiture by Respondents was Monday, June 17, 2013.

6. The Defendant was not returned to custody within 90 days, nor was the face amount of the bond forfeitures deposited with the Court Clerk on the 91st day after receipt of the Order and Judgment of Forfeiture.

7. On Tuesday, June 18, 2013—the 92nd day—Davis paid the bond forfeitures.

CONCLUSIONS OF LAW

1. The allegations are found to be true and correct, and Respondents have violated 59 O.S. § 1332 by failing to return the Defendant within ninety (90) days or remit payment in the face amount of the bond forfeiture within ninety-one (91) days from receipt of the Order and Judgment of Forfeiture.

ORDER

**IT IS THEREFORE ORDERED that Eddie Burton and Doyle Davis are each
CENSURED.**

Respondents are further notified that they may request a hearing within 30 days of the receipt of this Order concerning this action, and upon such request, the Oklahoma Insurance Department shall conduct a hearing before an independent hearing examiner. A request for hearing shall be made in writing to Buddy Combs, Oklahoma Insurance Department, Legal Division, 3625 NW 56th Suite 100, Oklahoma City, Oklahoma 73112 and **give an explanation of Respondents' actions alleged herein and any defenses thereto.**

If Respondents do not request a hearing within the 30 days allotted, this Order shall become a FINAL ORDER on the 31st day following the receipt of the Order.
