CONDITIONAL ADMINISTRATIVE ORDER AND NOTICE OF RIGHT TO BE HEARD

COMES NOW the State of Oklahoma, ex rel. John D. Doak, Insurance Commissioner, by and through counsel and alleges and states as follows:

JURISDICTION

- 1. John D. Doak is the Insurance Commissioner of the State of Oklahoma and as such is charged with the duty of administering and enforcing all provisions of the Oklahoma Insurance Code, 36 O.S. §§ 101-7301, and the Oklahoma Bail Bond Act, 59 O. S. §§ 1301-1340.
- Respondent Charles Coleman ("Coleman") is a licensed bail bondsman in the State of Oklahoma holding license number 93317.
- 3. Respondent Curtis Pletcher ("Pletcher") is a licensed professional bail bondsman in the State of Oklahoma holding license number 199574.

FINDINGS OF FACT

1. On or about December 30, 2012, an appearance bond was executed as follows:

2. On March 20, 2013, the Defendant failed to appear, and the bond was declared forfeited. An Order and Judgment of Forfeiture was issued by the court and filed in the case. A true and correct copy of the Order and Judgment of Forfeiture was mailed to Respondents with return receipt requested within thirty (30) days after the forfeiture's filing.

- 3. Coleman received a copy of the Order and Judgment of Forfeiture on April 4, 2013.
- 4. Pletcher received a copy of the Order and Judgment of Forfeiture on April 8, 2013.
- 5. The ninety-first (91st) day after receipt of the Order and Judgment of Forfeiture by Respondents was Thursday, July 4, 2013. Because that day was a holiday, the statutory 91st day was Friday, July 5, 2013.
- 6. The Defendant was not returned to custody within 90 days, nor was the face amount of the bond forfeitures deposited with the Court Clerk on the 91st day after receipt of the Order and Judgment of Forfeiture.
- 7. As of the date of this Order, the bond forfeiture has not been paid or otherwise set aside or the bond exonerated.

CONCLUSIONS OF LAW

1. The allegations are found to be true and correct, and Respondents have violated 59 O.S. § 1332 by failing to return the Defendant within ninety (90) days or remit payment in the face amount of the bond forfeiture within ninety-one (91) days from receipt of the Order and Judgment of

Forfeiture.

ORDER

IT IS THEREFORE ORDERED that Charles Coleman and Curtis Pletcher are <u>each</u>
CENSURED and FINED Three Hundred Twenty Dollars (\$320.00).

IT IS FURTHER ORDERED that pursuant 59 O.S. § 1332 the face amount of the bond, Three Thousand Two Hundred One Dollars (\$3,201.00), shall be withdrawn from the deposit placed with the State of Oklahoma by Curtis Pletcher as reserve to meet sums due on forfeiture. The sums withdrawn are to be forwarded to the Bethany Municipal Court Clerk for payment of the bond in case number CR-2008-4654, Defendant Robert A. Pitts. Such sums shall not be withdrawn from the deposit of Curtis Pletcher if the bond forfeiture is paid or otherwise set aside within 30 days of receipt of this Order.


Respondents are further notified that they may request a hearing within 30 days of the receipt of this Order concerning this action, and upon such request, the Oklahoma Insurance Department shall conduct a hearing before an independent hearing examiner. A request for hearing shall be made in writing to Buddy Combs, Oklahoma Insurance Department, Legal Division, 3625 NW 56th Suite 100, Oklahoma City, Oklahoma 73112 and give an explanation of Respondents' actions alleged herein and any defenses thereto.

If Respondents do not request a hearing within the 30 days allotted, this Order shall become a FINAL ORDER on the 31st day following the receipt of the Order and the face amount of the bond forfeiture shall be withdrawn from Curtis Pletcher's professional deposit and forwarded to the Bethany Municipal Court Clerk.

Any fine ordered herein shall be due and payable to the Oklahoma Insurance Department

within 30 days after the date this Order becomes a Final Order.
