**CONDITIONAL ADMINISTRATIVE ORDER
AND NOTICE OF RIGHT TO BE HEARD**

COMES NOW the State of Oklahoma, ex rel. John D. Doak, Insurance Commissioner, by and through counsel and alleges and states as follows:

JURISDICTION

1. John D. Doak is the Insurance Commissioner of the State of Oklahoma and as such is charged with the duty of administering and enforcing all provisions of the Oklahoma Insurance Code, 36 O.S. §§ 101-7301, and the Oklahoma Bail Bond Act, 59 O. S. §§ 1301-1340.
2. Respondent James Manuel (“Respondent”) is a licensed bail bondsman in the State of Oklahoma holding license number 200341.

FINDINGS OF FACT

1. On August 8, 2013, Respondent submitted to the Oklahoma Insurance Department (“the Department”) his Second Amended July 2013 Roche Surety & Casualty Company (“RSCC”) surety report.
2. With the report, Respondent submitted an Electronic Funds Transfer (“EFT”) of Three Dollars (\$3.00).

3. The Oklahoma State Treasurer charged the EFT back to the Department as “R04 – Invalid Account Number.”

4. As of the date of this Order, Respondent’s license is suspended in case 13-0825-DIS for an identical violation.

5. As of the date of this Order, Respondent has not replaced the fees he owes for the above-referenced report.

CONCLUSIONS OF LAW

1. Respondent has violated 59 O.S. § 1314(D) by failing to submit the proper fee with his reports.

2. Pursuant to 59 O.S. § 1310, the Insurance Commissioner may suspend the license of any bondsman for the above-referenced violation.

ORDER

IT IS THEREFORE ORDERED by the Insurance Commissioner that Respondent is CENSURED.

IT IS FURTHER ORDERED that if Respondent fails to replace the \$3.00 EFT within 30 days of receipt of this Order, Respondent’s bail bondsman license shall be suspended upon this Order becoming a Final Order. This suspension is in addition to his current suspension, and shall continue until such time as he replaces the EFT.

IT IS FURTHER ORDERED that Respondent is hereby given notice of opportunity to request a hearing within thirty (30) calendar days of receipt of this order to determine if there are any reasons why Respondent’s bondsman license should not be subject to suspension. If Respondent requests a hearing before the Insurance Commissioner or his duly appointed hearing


examiner, the proceedings shall be conducted within ten business days after receipt of the request and in accordance with the Oklahoma Bail Bond Act, OKLA. STAT. tit. 59 §§ 1301 et seq., and the Oklahoma Administrative Procedures Act, OKLA. STAT. tit. 75, §§ 250 et seq.

If Respondent fails to request a hearing within 30 days of receipt, this Order shall become a Final Order on the 31st day following receipt.


