CONDITIONAL ADMINISTRATIVE ORDER AND NOTICE OF RIGHT TO BE HEARD

COMES NOW the State of Oklahoma, ex rel. John D. Doak, Insurance Commissioner, by and through counsel and alleges and states as follows:

JURISDICTION

- 1. John D. Doak is the Insurance Commissioner of the State of Oklahoma and as such is charged with the duty of administering and enforcing all provisions of the Oklahoma Insurance Code, 36 O.S. §§ 101-7301, and the Oklahoma Bail Bond Act, 59 O. S. §§ 1301-1340.
- 2. Respondent Keith Miller ("Respondent") is a licensed bail bondsman in the State of Oklahoma holding license number 117750.

FINDINGS OF FACT

- 1. Respondent submitted his March 2013 Seneca Insurance Company ("SIC") report to the Oklahoma Insurance Department ("Department") on April 16, 2013. The report was due on April 15, 2013.
- 2. Respondent submitted his June 2013 SIC report to the Department on July 19, 2013. The report was due on July 15, 2013.
 - 3. Respondent submitted his July 2013 SIC report to the Department on August 22,

2013. The report was due on August 15, 2013.

CONCLUSIONS OF LAW

1. Respondent has violated 59 O.S. § 1310(A)(22) and § 1314 for filing late monthly reports.

ORDER

IT IS THEREFORE ORDERED that Keith Miller is FINED Two Hundred Fifty Dollars (\$250.00).

Respondent is further notified that he may request a hearing within 30 days of the receipt of this Order concerning this action, and upon such request, the Oklahoma Insurance Department shall conduct a hearing before an independent hearing examiner. A request for hearing shall be made in writing to Buddy Combs, Oklahoma Insurance Department, Legal Division, 3625 NW 56th St., Suite 100, Oklahoma City, Oklahoma 73112, and state the basis for requesting the hearing.

If Respondent does not request a hearing within the 30 days allotted, this Order shall become a FINAL ORDER on the 31st day following the receipt of the Order, and the fine ordered herein shall be due.
