CONDITIONAL ADMINISTRATIVE ORDER AND NOTICE OF RIGHT TO BE HEARD

COMES NOW the State of Oklahoma, ex rel. John D. Doak, Insurance Commissioner, by and through counsel and alleges and states as follows:

JURISDICTION

- 1. John D. Doak is the Insurance Commissioner of the State of Oklahoma and as such is charged with the duty of administering and enforcing all provisions of the Oklahoma Insurance Code, 36 O.S. §§ 101-7301, and the Oklahoma Bail Bond Act, 59 O. S. §§ 1301-1340.
- 3. Respondent Seneca Insurance Company ("the Company") is an insurance company licensed to act as bail surety in the State of Oklahoma holding NAIC number 10936.

FINDINGS OF FACT

1. Pursuant to Oklahoma Administrative Code 365:25-5-41(C), the Company is required to maintain a special deposit equal to at least a ten-to-one (10:1) ratio of outstanding liability-to-deposit. The Company's deposit and outstanding liability for the months of January 2013 through August 2013 are as follows:

- 2. Between January 2013 and August 2013, the Company's outstanding liability increased by \$3,969,990, but the Company did not increase its deposit.
- 3. On August 8, 2013, Oklahoma Insurance Department ("Department") personnel sent an E-mail to the Company for a mid-year review, and notified the Company that its deposit was short of the legal requirement. The Company was given a due date of August 29, 2013, by which it was to increase the deposit.
- 4. On August 15, 2013, the Company responded via E-mail and notified the Department of its intention to purchase a certificate of deposit to cover the shortfall in its deposit.
- 5. On October 3, 2013, the Company notified the Department of its intention to purchase a certificate of deposit in the amount of \$500,000.00 to cover the shortfall in its deposit.
- 6. As of the date of this Conditional Order, the Company has not deposited additional securities in order to bring its liability-to-deposit ratio within the limits mandated by OAC 365:25-5-41(C).

CONCLUSIONS OF LAW

- 1. The allegations are found to be true and correct, and Seneca Insurance Company has violated 59 O.S. § 1310(A)(7) by failing to comply with a proper rule of the Commissioner.
- 2. Seneca Insurance Company has violated OAC 365:25-5-41 by exceeding a liability-to-deposit of 10:1.
- 3. Pursuant to 59 O.S. § 1310(B), any bondsman or company violating a provision of the Bail Bond Act, 59 O.S. §§ 1301-1340, may be subject to a fine of not less than \$250 but not more than \$2,500.

ORDER

IT IS THEREFORE ORDERED that Seneca Insurance Company shall deposit additional securities with the Oklahoma Insurance Department sufficient to bring its liability-to-deposit ratio within the prescribed limitations. If Seneca Insurance Company does not make said deposit on or before the 30th day after its receipt of this Order, the Company's license privilege and authorization to do business in the State of Oklahoma shall be **SUSPENDED**.

IT IS FURTHER ORDERED that Seneca Insurance Company is **CENSURED** and **FINED**Two Thousand Five Hundred Dollars (\$2,500.00).

The Company is further notified that it may request a hearing within 30 days of the receipt of this Order concerning this action, and upon such request, the Oklahoma Insurance Department shall conduct a hearing before an independent hearing examiner. A request for hearing shall be made in writing to Buddy Combs, Oklahoma Insurance Department, Legal Division, 3625 NW 56th Suite 100, Oklahoma City, Oklahoma 73112, and <u>give an explanation of Respondent's actions alleged herein and any defenses thereto.</u>

If Respondent does not request a hearing within the 30 days allotted, this Order shall become a FINAL ORDER on the 31st day following the receipt of the Order.
