



4. Respondent filed his July 2013 RSCC report on August 18, 2013. The report was due on August 15, 2013.

5. Respondent filed his August 2013 RSCC report on September 20, 2013. The report was due September 16, 2013.

6. Respondent failed to file with the Insurance Commissioner his September 2013 RSCC surety report, which was due October 15, 2013.

7. On October 16, 2013, as a courtesy, Department staff sent Respondent an email regarding his failure to file the report.

8. As of the date of this Order, Respondent has not filed the report.

#### **CONCLUSIONS OF LAW**

1. Respondent has violated 59 O.S. § 1310(A)(22) for failing to file reports as required by Section 1314, which states that “monthly reports shall be submitted electronically to the Insurance Commissioner by the fifteenth day of each month.”

2. Pursuant to 59 O.S. § 1310(A), the Commissioner “may deny, censure, suspend, revoke, or refuse to renew any license issued” under the Bail Bond Act for the above-alleged violation.

3. Pursuant to 59 O.S. § 1310(B), “any person violating any provision of Sections 1301 through 1340 of this title may be subject to a civil penalty of not less than Two Hundred Fifty Dollars (\$250.00) nor more than Two Thousand Five Hundred Dollars (\$2,500.00) for each occurrence.”

#### **ORDER**

**IT IS THEREFORE ORDERED that Jason Still is CENSURED and FINED Five**

Hundred Dollars (\$500.00).

**IT IS FURTHER ORDERED** that Jason Still shall file his September 2013 RSCC report and pay all associated fees within 30 days of receipt of this Order. If he does not, his license shall be **SUSPENDED** on the 31<sup>st</sup> day following receipt, and the suspension shall remain in effect until the report and fees are submitted to the Department.


Respondent is notified that he may request a hearing within 30 days of the receipt of this Order concerning this action, and upon such request, the Oklahoma Insurance Department shall conduct a hearing before an independent hearing examiner. A request for hearing shall be made in writing to Buddy Combs, Oklahoma Insurance Department, Legal Division, 3625 NW 56<sup>th</sup> St., Suite 100, Oklahoma City, Oklahoma 73112, and **give an explanation of Respondent's actions alleged herein and any defenses thereto.**

**If Respondent does not request a hearing within the 30 days allotted, this Order shall become a FINAL ORDER on the 31<sup>st</sup> day following the receipt of the Order.**



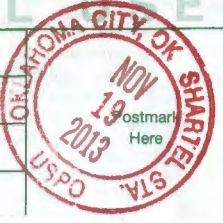
