**ADMINISTRATIVE ORDER**

This matter is a disciplinary proceeding under the Oklahoma Bail Bond Act. The Oklahoma Insurance Department (the "Department") issued a Notice of Hearing and Order to Show Cause on March 25, 2014, alleging that Respondent Charles Terrell Coleman ("Coleman" or "Respondent") violated numerous provisions of the Bail Bond Act.

The hearing was set before the undersigned Hearing Examiner for April 22, 2014.

Petitioner appeared through Counsel Dan R. Byrd on April 22, 2014. Respondent failed to appear. Petitioner offered Exhibit 1 as proof to support the proper service upon Respondent by certified mail at the Respondent's current address of record with the Department. Petitioner offered Exhibits A through H as proof to support the allegations of fact and alleged violations of law contained in the Notice of Hearing and Order to Show Cause.

**JURISDICTION**

1. John D. Doak is the Insurance Commissioner of the State of Oklahoma and as such is charged with the duty of administering and enforcing all provisions of the Oklahoma Insurance Code, 36 O.S. §§ 101-7301, and the Oklahoma Bail Bond Act, 59 O. S. §§ 1301-1340.

2. Respondent was a licensed bail bondsman in the State of Oklahoma holding license number 93317.

3. The Insurance Commissioner may deny, censure, suspend, revoke, or refuse to renew any license issued pursuant to the Oklahoma Bail Bond Act and/or may levy a fine of not less than \$250.00 but not more than \$2,500.00 for each occurrence of a violation of the Oklahoma Bail Bond Act. 59 O.S. § 1310(A) and (B).

### **FINDINGS OF FACT**

1. Respondent submitted his December 2013 Lexington National Insurance Corporation report to the Oklahoma Insurance Department ("Department") on Thursday, January 16, 2014 - 1 day after the report was due on Wednesday, January 15, 2014. This was Respondent's fifth occurrence of filing reports late with the Department.

2. On May 15, 2013, Respondent executed an appearance bond in the amount of Two Thousand Dollars (\$2,000.00) using power of attorney number 42283 from insurer Curtis Pletcher for Defendant, Aron Stevenson, in Oklahoma County District Court Case No. CF-2003-7025. See Appearance Bond dated May 15, 2013, attached hereto as Exhibit "A".

3. On May 15, 2013, Respondent executed an appearance bond in the amount of Seventy-One Thousand Dollars (\$71,000.00) using power of attorney number 46678 from insurer Curtis Pletcher for Defendant, Aron Stevenson, in Oklahoma County District Court Case No. CF-2013-2220. See Appearance Bond dated May 15, 2013, attached hereto as Exhibit "B".

4. On January 22, 2014, Defendant, Aron Stevenson, entered a guilty plea in both cases CF-2003-7025 and CF-2013-2220 and Respondent signed an agreement to remain on the appearance bonds in both cases. See plea and agreement to remain on appearance bonds, attached hereto as

Exhibit "C".

5. On January 8, 2014, Marsha Widener executed an appearance bond in the amount of Three Thousand Dollars (\$3,000.00) using power of attorney from insurer Raymond Merrill for Defendant, Aron Stevenson, in Oklahoma County District Court Case No. CF-2014-80. See Appearance Bond dated January 8, 2014, attached hereto as Exhibit "D". Although Respondent did not execute this appearance bond, on January 22, 2014, Respondent signed an agreement to remain on the appearance bond. See Exhibit "C".

6. On January 22, 2014, the date that Respondent had agreed to remain on the three appearance bonds referenced above, he was not appointed with insurer Curtis Pletcher. Respondent's appointment with Curtis Pletcher had been cancelled on July 12, 2013. See attached Cancellation of Appointment Bail Bond Form-BCAA dated July 12, 2013, attached hereto as Exhibit "E". Respondent has never been appointed with insurer Raymond Merrill and Raymond Merrill had never consented to Respondent signing an agreement to remain on an appearance bond. See letter dated February 19, 2014, from Debra Hamilton/Office Manager, Merrill Bonding Company to Anna Denman, Oklahoma Insurance Department, attached hereto as Exhibit "F". Therefore, Respondent did not represent either of the insures referenced above at the time he agreed to remain on the three appearance bonds referenced above.

7. On February 4, 2014, the Department received three complaints from the Oklahoma County Court Clerk advising the Department that Respondent agreed to remain on three appearance bonds for Defendant, Aron Stevenson after his license from the insurer was revoked, expired and not appointed as an agent. See Agreements to Remain on Bond After Bail Bonds License was Revoked and Expired and Not Appointed as an Agent dated January 30, 2014, attached hereto as Exhibit "G".

8. On September 25, 2013, the Department received the first Revocation Order from the Oklahoma Department of Human Services for Respondent. Respondent's bail bond license expired on September 30, 2013. On November 19, 2013, the Oklahoma Department of Human Services reinstated Respondent's license, however, the license was expired and Respondent had not attempted to renew his license. On January 10, 2014, the Department received a second Revocation Order from the Oklahoma Department of Human Services for Respondent.

9. On May 20, 2013, Respondent executed cash bonds for Defendant Aron Stevenson in Oklahoma County District Court Case Nos. FD-1998-96 and FD-1999-2964. Respondent has never held the cash line of authority. If a bail bondsman executes a cash bond, he must hold the cash line of authority pursuant to Department Bulletin BB 2013-02. See Department Bulletin BB 2013-02, attached hereto as Exhibit "H".

10. Respondent has a lengthy administrative history with the Department. Respondent's license has been revoked by the Oklahoma Department of Human Services twice, he has a Tax Hold from the Oklahoma Tax Commission and he currently owes a fine to the Department. Respondent is a defendant in Oklahoma County District Court Case No. CF-2012-7226, which demonstrates financial irresponsibility.

#### **CONCLUSIONS OF LAW**

1. Respondent has violated 59 O.S. § 1310(A)(2) by violating a law of this state relating to bail.

2. Respondent has violated 59 O.S. § 1310(A)(6) by demonstrating financial irresponsibility in conducting his business under his license.

3. Respondent has violated 59 O.S. § 1310(A)(7) by failing to comply with, or violation

of any proper order, rule, or regulation of the Commissioner.

4. Respondent has violated 59 O.S. § 1310(A)(9) by conducting his business in a manner that renders the Respondent unfit to carry on the bail bond business or making the continuance of the business detrimental to the public interest in the judgment of the Commissioner.

**ORDER**


Petitioner's admitted Exhibits A through H and testimony offered at hearing support the Allegations of Fact and Alleged Violations of Law in the Notice of Hearing and Order to Show Cause as true and correct.

**IT IS THEREFORE ORDERED** that Charles Terrell Coleman's bail bondsman license is **REVOKED**.

**IT IS FURTHER ORDERED** that Charles Terrell Coleman is assessed the costs of the hearing in the amount of Two Hundred Dollars (\$200.00), due and payable to the Oklahoma Insurance Department within 30 days after the date of hearing.

Title 59, Section 1303 of the Oklahoma Statutes prohibits an unlicensed individual from acting as a bail bondsman, except in two very narrow circumstances:

A. No person shall act in the capacity of a bail bondsman or perform any of the functions, duties or powers prescribed for bail bondsmen under the provisions of Section 1301 et seq. of this title, unless that person shall be qualified and licensed as provided in Section 1301 et seq. of this title or as authorized pursuant to the Bail Enforcement and Licensing Act. Provided, however, none of the provisions or terms of this section shall prohibit any individual or individuals from:

1. Pledging real or other property as security for a bail bond for himself, herself or another in judicial proceedings who does not receive, or is not promised, a fee or charge for his or her services provided such person shall not be permitted to make in excess of ten bonds per year; or
2. Executing any bail bond for an insurer, pursuant to a bail bond service agreement entered into between such insurer and any automobile club or association, financing institution, insurance company or other organization or association, on behalf of a person required to furnish bail in connection with any violation of law arising out of the use of a motor vehicle.

Pursuant to 59 O.S. § 1303(A)(1), unlicensed individuals may pledge cash or property for a bail bond, provided that they do not charge for the service and they do not make more than 10 such bonds in a year. This statute was intended to allow people to secure the release of friends and



family members without using a bondsman. The law does not create a blanket exception which would allow a licensed bail bondsman without a cash or property line of authority to make a cash or property bond.

Any bondsman wishing to make cash or property bonds must obtain the proper line of authority before doing so.

If you have any concerns or wish to receive clarification on this or any other provision of the Bail Bond Act, Insurance Department personnel will gladly assist you.
