**CONDITIONAL ADMINISTRATIVE ORDER  
AND NOTICE OF RIGHT TO BE HEARD**

COMES NOW the State of Oklahoma, ex rel. John D. Doak, Insurance Commissioner, by and through counsel and alleges and states as follows:

**JURISDICTION**

1. John D. Doak is the Insurance Commissioner of the State of Oklahoma and as such is charged with the duty of administering and enforcing all provisions of the Oklahoma Insurance Code, 36 O.S. §§ 101-7301, and the Oklahoma Bail Bond Act, 59 O. S. §§ 1301-1340.
2. Respondent Richard Husmann (“Husmann”) is a licensed bail bondsman in the State of Oklahoma holding license number 40113119.
2. Respondent Roberta Ann Dampf Augilar (“Augilar”) is a licensed professional bail bondsman in the State of Oklahoma holding license number 199461.

## **FINDINGS OF FACT**

1. On or about December 31, 2013, an appearance bond was executed as follows:

Defendant:	Amanda Sue Tyler
Case Number(s):	CM-2014-187
City/County:	Tulsa County
Surety:	Roberta Ann Dampf Augilar
Bondsman:	Richard Husmann
Power Number(s):	ABB-13-21805
Bond Amount(s):	\$250

2. On February 18, 2014, the Defendant failed to appear, and the bond was orally declared forfeited. An Order and Judgment of Forfeiture was filed by the court on February 21, 2014. A true and correct copy of the Order and Judgment of Forfeiture was mailed to Respondents with return receipt requested within thirty (30) days after the Order's filing.

3. Husmann received a copy of the Order and Judgment of Forfeiture on February 27, 2014.

4. Aguilar received a copy of the Order and Judgment of Forfeiture on February 27, 2014.

5. The ninetieth (90<sup>th</sup>) day after receipt of the Order and Judgment of Forfeiture by Respondents was Wednesday, May 28, 2014.

6. The ninety-first (91<sup>st</sup>) day after receipt of the Order and Judgment of Forfeiture by Respondents was Thursday, May 29, 2014.

7. The bond forfeiture was paid on May 30, 2014.

8. The Defendant was not returned to custody within 90 days, nor was the face amount of the forfeited bond deposited with the Court Clerk within 91 days, after receipt of the Order and Judgment of Forfeiture by Respondents.

## **CONCLUSIONS OF LAW**

1. The allegations are found to be true and correct, and Respondents have violated 59 O.S.

§ 1332 by failing to return the Defendant within ninety (90) days or remit payment in the face amount of the bond forfeiture within ninety-one (91) days from receipt of the Order and Judgment of Forfeiture.

2. Pursuant to 59 O.S. § 1310(B), any bondsman or company violating a provision of the Bail Bond Act, 59 O.S. §§ 1301-1340, may be subject to a fine of not less than \$250 but not more than \$2,500.

**ORDER**

**IT IS THEREFORE ORDERED** that Roberta Ann Dampf Augilar and Richard Husmann are each **CENSURED**.

**If Respondents do not request a hearing within the 30 days allotted, this Order shall become a FINAL ORDER on the 31<sup>st</sup> day following the receipt of the Order.**


