CONDITIONAL ADMINISTRATIVE ORDER AND NOTICE OF RIGHT TO BE HEARD

COMES NOW the State of Oklahoma, ex rel. John D. Doak, Insurance Commissioner, by and through counsel and alleges and states as follows:

JURISDICTION

- 1. John D. Doak is the Insurance Commissioner of the State of Oklahoma and as such is charged with the duty of administering and enforcing all provisions of the Oklahoma Insurance Code, 36 O.S. §§ 101-7301, and the Oklahoma Bail Bond Act, 59 O. S. §§ 1301-1340.
- 2. Respondent Lacey Davis ("L. Davis") is a licensed bail bondsman in the State of Oklahoma holding license number 199287.
- 2. Respondent Doyle Davis ("D. Davis") is a licensed professional bail bondsman in the State of Oklahoma holding license number 199421.

FINDINGS OF FACT

1. On or about June 28, 2013, appearance bonds were executed as follows:

Defendant: Adrian Flores

Case Number(s): 393298, 393298A, 393298B City/County: Tulsa Municipal Court

Surety: Doyle Davis Bondsman: Lacey Davis

Power Number(s): 20080, 20081, 20082 Bond Amount(s): \$750, \$200, \$200 = \$1150

2. On January 8, 2014, the Defendant failed to appear, and the bonds were orally declared forfeited. Orders and Judgments of Forfeitures were filed by the court on January 17, 2014. A true and correct copy of the Orders and Judgments of Forfeitures were mailed to Respondents with return receipt requested within thirty (30) days after the Orders' filing.

- 3. L. Davis received a copy of the Orders and Judgments of Forfeitures on January 21, 2014.
- 4. D. Doyle received a copy of the Orders and Judgments of Forfeitures on January 21, 2014.
- 5. The ninetieth (90th) day after receipt of the Orders and Judgments of Forfeitures by Respondents was Monday, April 21, 2014.
- 6. The ninety-first (91st) day after receipt of the Orders and Judgments of Forfeitures by Respondents was Tuesday, April 22, 2014.
- 7. As of the date of this Order, the bond forfeitures have not been paid or otherwise set aside or the bonds exonerated.
- 8. The Defendant was not returned to custody within 90 days, nor was the face amount of the forfeited bonds deposited with the Court Clerk within 91 days, after receipt of the Orders and

Judgments of Forfeitures by Respondents.

CONCLUSIONS OF LAW

- 1. The allegations are found to be true and correct, and Respondents have violated 59 O.S. § 1332(D) by failing to return the Defendant within ninety (90) days or remit payment in the face amount of the bond forfeitures within ninety-one (91) days from receipt of the Orders and Judgments of Forfeitures.
- 2. Pursuant to 59 O.S. § 1310(B), any bondsman or company violating a provision of the Bail Bond Act, 59 O.S. §§ 1301-1340, may be subject to a fine of not less than \$250 but not more than \$2,500.
- 3. Pursuant to 59 O.S. § 1332(D)(4)(a), when a surety bondsman does not properly deposit with the court clerk the face amount of the forfeited bond, the Commissioner shall "cancel the license privilege and authorization of the insurer to do business within the State of Oklahoma and cancel the surety appointment of all surety bondsman agents of the insurer.

ORDER

IT IS THEREFORE ORDERED that Lacey Davis and Doyle Davis are <u>each</u> CENSURED and FINED Two Hundred Fifty Dollars (\$250.00).

IT IS FURTHER ORDERED that the face amount of the bond forfeitures shall be deposited with the Tulsa Municipal Court Clerk (or the bond forfeitures otherwise set aside or the bonds exonerated) within thirty (30) days of receipt of this Order. Failure to do so shall result in the CANCELLATION of Doyle Davis' license privilege and authorization to do business within the State of Oklahoma and CANCELLATION of the surety appointment of all surety bondsman agents of Doyle

Davis.

Respondents are further notified that they may request a hearing within 30 days of the receipt of this Order concerning this action, and upon such request, the Oklahoma Insurance Department shall conduct a hearing before an independent hearing examiner. A request for hearing shall be made in writing to Dan R. Byrd, Assistant General Counsel, Oklahoma Insurance Department, Legal Division, 3625 NW 56th Suite 100, Oklahoma City, Oklahoma 73112 and give an explanation of Respondents' actions alleged herein and any defenses thereto.

If Respondents do not request a hearing within the 30 days allotted, this Order shall become a FINAL ORDER on the 31st day following the receipt of the Order, and the fines ordered herein shall be due.
