CONDITIONAL ADMINISTRATIVE ORDER AND NOTICE OF RIGHT TO BE HEARD

COMES NOW the State of Oklahoma, ex rel. John D. Doak, Insurance Commissioner, by and through counsel and alleges and states as follows:

JURISDICTION

- 1. John D. Doak is the Insurance Commissioner of the State of Oklahoma and as such is charged with the duty of administering and enforcing all provisions of the Oklahoma Insurance Code, 36 O.S. §§ 101-7301, and the Oklahoma Bail Bond Act, 59 O. S. §§ 1301-1340.
- 2. Respondent Taylor Caldwell ("Respondent") is a licensed bail bondsman in the State of Oklahoma holding license number 100180131.

FINDINGS OF FACT

- Respondent was first licensed on January 7, 2014 and was appointed with professional 1. bail bondsman James Lawson from February 6, 2014 until July 15, 2014. Respondent does not have any other appointments. Once Respondent was cancelled by James Lawson she was required to submit a monthly report for her Surety Bail line of authority ("LoA").
- 2. Respondent failed to file her November 2014 Surety report with the Oklahoma Insurance Department ("Department"), which was due Monday, December 15, 2014.

- 3. Respondent failed to file her December 2014 Surety report with the Department, which was due Thursday, January 15, 2015.
- 4. Department staff sent email letters to Respondent on December 22, 2014 and January 26, 2014.
- 5. On January 29, 2014, Department staff left a message at Respondent's telephone number on file with the Department, (918) 385-2422, advising her to file her reports. Respondent has not returned the telephone call.
- 6. Respondent has not filed her July, August and October 2014 surety reports. Her September 2014 surety report was filed late on October 28, 2014.

CONCLUSIONS OF LAW

- 1. Respondent has violated 59 O.S. § 1310(A)(24) for failing to file a report as required by Section 1314.
- 2. Respondent has violated 59 O.S. § 1314(B), which states that "monthly reports shall be submitted electronically to the Insurance Commissioner by the fifteenth day of each month."
- 3. Pursuant to 59 O.S. § 1310(B), "any person violating any provision of Sections 1301 through 1340 of this title may be subject to a civil penalty of not less than Two Hundred Fifty Dollars (\$250.00) nor more than Two Thousand Five Hundred Dollars (\$2,500.00) for each occurrence."

ORDER

IT IS THEREFORE ORDERED that Taylor Caldwell is CENSURED and FINED Seven Hundred Fifty Dollars (\$750.00). Respondent is further notified that she may request a hearing within thirty (30) days of the receipt of this Order concerning this action, and upon such request, the Oklahoma Insurance Department shall conduct a hearing before an independent hearing examiner. A request for

hearing shall be made in writing to Dan R. Byrd, Oklahoma Insurance Department, Legal Division, 3625 NW 56th St., Suite 100, Oklahoma City, Oklahoma 73112, and <u>state the basis for requesting the hearing</u>.

If Respondent does not request a hearing within the thirty (30) days allotted, this Order shall become a FINAL ORDER on the thirty-first (31st) day following the receipt of the Order, and the fines ordered herein shall be due.
