

contained in the Notice of Hearing. Testimony was taken and arguments were heard. The Hearing Examiner finds as follows:

JURISDICTION

1. John D. Doak is the Insurance Commissioner of the State of Oklahoma and as such is charged with the duty of administering and enforcing all provisions of the Oklahoma Insurance Code, 36 O.S. §§ 101-7301, and the Oklahoma Bail Bond Act, 59 O. S. §§ 1301-1340.

2. Applicant is a licensed bail bondsman in the State of Oklahoma holding license number 100197432.

3. The Insurance Commissioner may deny, censure, suspend, revoke, or refuse to renew any license issued pursuant to the Oklahoma Bail Bond Act and/or may levy a fine of not less than \$250.00 but not more than \$2,500.00 for each occurrence of a violation of the Oklahoma Bail Bond Act. 59 O.S. § 1310(A) and (B).

FINDINGS OF FACT

1. Respondent was arrested on November 7, 2014 on DUI and traffic charges. On February 5, 2015 charges were filed in Oklahoma County Case No. CF-2015-891(Criminal Felony) for Driving While Under the Influence in violation of 47 O.S. § 11-902(A)(2).

2. On March 12, 2015 Respondent entered a negotiated plea of guilty and received a five year deferred sentence.

3. 59. O.S. § 1315(A)(1) prohibits persons convicted of, or who have pled guilty or nolo contendere to, any felony or to a misdemeanor involving dishonesty or moral turpitude from having a bail bond license.

CONCLUSIONS OF LAW

1. Respondent has violated 59 O.S. § 1315(A)(1) by pleading guilty to a felony.
2. Respondent has violated 59 O.S. § 1310(A)(2) by violating a law of this state relating to bail.


ORDER

Petitioner's testimony offered at hearing support the Statement of Facts and Alleged Violations of Law in the Notice of Hearing.

IT IS THEREFORE ORDERED that Brian Michael Erwin's bail bond license is revoked.


