

CONCLUSIONS OF LAW

1. The allegations are found to be true and correct, and Respondents have violated 59 O.S. § 1310(A)(16), by soliciting business in Pryor Municipal Police Department/Jail.

ORDER

IT IS THEREFORE ORDERED that Rodney Dwayne Steddum is **FINED** Five Hundred Dollars (\$500.00). The fine is to be paid within Thirty (30) days from receipt of this Order. If Respondent fails to pay said fine, his license will be suspended and will remain suspended until the fine is paid in full.

Respondents are further notified that they may request a hearing within 30 days of the receipt of this Order concerning this action, and upon such request, the Oklahoma Insurance Department shall conduct a hearing before an independent hearing examiner. A request for hearing shall be made in writing to Matt McKinnon, Assistant General Counsel, Oklahoma Insurance Department, Legal Division, 3625 NW 56th Suite 100, Oklahoma City, Oklahoma 73112 and **give an explanation of Respondent's actions alleged herein and any defenses thereto.**

If Respondents do not request a hearing within the 30 days allotted, this Order shall become a FINAL ORDER on the 31st day following the receipt of the Order, and the fines ordered herein shall be due.

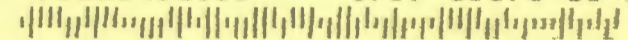
