## CONDITIONAL ADMINISTRATIVE ORDER AND NOTICE OF RIGHT TO BE HEARD

COMES NOW the State of Oklahoma, ex rel. John D. Doak, Insurance Commissioner, by and through counsel and alleges and states as follows:

### **JURISDICTION**

- 1. John D. Doak is the Insurance Commissioner of the State of Oklahoma and as such is charged with the duty of administering and enforcing all provisions of the Oklahoma Insurance Code, 36 O.S. §§ 101-7301, and the Oklahoma Bail Bond Act, 59 O. S. §§ 1301-1340.
- 2. Respondent Rodney Dwayne Steddum ("Steddum") is a licensed professional bail bondsman in the State of Oklahoma holding license number 86786.

#### FINDINGS OF FACT

- On or about July 22, 2015 the Bail Bonds Division of the Oklahoma Insurance Department received a complaint regarding Respondent giving business cards to individuals at Pryor Municipal Police Department/Jail.
- 2. Video footage provided by the Pryor Police Department shows clearly Steddum in the lobby of the building which houses inmates, handing business cards to two women.

#### **CONCLUSIONS OF LAW**

1. The allegations are found to be true and correct, and Respondents have violated 59 O.S. § 1310(A)(16), by soliciting business in Pryor Municipal Police Department/Jail.

#### **ORDER**

IT IS THEREFORE ORDERED that Rodney Dwayne Steddum is FINED Five Hundred Dollars (\$500.00). The fine is to be paid within Thirty (30) days from receipt of this Order. If Respondent fails to pay said fine, his license will be suspended and will remain suspended until the fine is paid in full.

Respondents are further notified that they may request a hearing within 30 days of the receipt of this Order concerning this action, and upon such request, the Oklahoma Insurance Department shall conduct a hearing before an independent hearing examiner. A request for hearing shall be made in writing to Matt McKinnon, Assistant General Counsel, Oklahoma Insurance Department, Legal Division, 3625 NW 56<sup>th</sup> Suite 100, Oklahoma City, Oklahoma 73112 and give an explanation of Respondent's actions alleged herein and any defenses thereto.

If Respondents do not request a hearing within the 30 days allotted, this Order shall become a FINAL ORDER on the 31<sup>st</sup> day following the receipt of the Order, and the fines ordered herein shall be due.
