## **ORDER OF LICENSE PROBATION**

**COMES NOW** the State of Oklahoma, ex rel. John D. Doak, Insurance Commissioner, by and through his undersigned counsel, and alleges and states as follows:

#### **JURISDICTION**

- 1. John D. Doak is the Insurance Commissioner of the State of Oklahoma and is charged with the duty of administering and enforcing all provisions of the Oklahoma Insurance Code, 36 O.S. §§ 101 et seq.
- 2. Brian Riddle is an applicant for a resident insurance producer license. His address of record is 220 NE Avondale, Bartlesville, Oklahoma 74006.
- 3. The Insurance Commissioner may place on probation, censure, suspend, revoke or refuse to issue or renew a license issued pursuant to the Oklahoma Producer Licensing Act and/or may levy a fine up to \$1,000.00 for each occurrence of a violation of the Oklahoma Insurance Code. 36 O.S. § 1435.13(A) and (D).

# FINDINGS OF FACT

- 1. Respondent Brian Riddle submitted an application for a producer license on October 26, 2015. Riddle disclosed that he pled no contest to a felony count of possession of controlled dangerous substance and a felony count of knowingly receiving stolen property in Kay County, Case No. CF-2014-616 on May 8, 2015. He received a three year deferred judgment on both counts until May 4, 2018.
- 2. Riddle fully disclosed his criminal background and provided the requisite documents to review.

### **CONCLUSIONS OF LAW**

The Insurance Commissioner may place a licensee on probation pursuant to 36 O.S. § 1435.13(A).

#### **ORDER**

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED by the Insurance Commissioner that Riddle is granted a producer license on a probationary status. Riddle will remain on probation until he reaches his deferred judgment date of May, 4, 2018. Riddle may request that probation be removed at that time. If his deferred judgment status changes before that date, Riddle shall report such to the Commissioner and may be subject to revocation of his license at that time.
