**CONDITIONAL ADMINISTRATIVE ORDER
AND NOTICE OF RIGHT TO BE HEARD**

COMES NOW the State of Oklahoma, ex rel. John D. Doak, Insurance Commissioner, by and through counsel, and alleges and states as follows:

JURISDICTION

1. John D. Doak is the Insurance Commissioner of the State of Oklahoma and, as such, is charged with the duty of administering and enforcing all provisions of the Oklahoma Insurance Code, 36 O.S. §§ 101-7301, and the Oklahoma Bail Bond Act, 59 O. S. §§ 1301-1340.
2. Respondent is a licensed bail bondsman in the State of Oklahoma, holding license number 199070.

FINDINGS OF FACT

1. Pursuant to 59 O.S. § 1314(B) and OAC 365:25-5-36, each bail bondsman is required to submit electronically filed monthly reports to the Insurance Commissioner ("Commissioner") within fifteen (15) days after the end of each preceding month. Said reports must be filed electronically with the Commissioner.
2. February, 2015 monthly bail bond reports were due to be filed with the Commissioner by

Monday, March 16, 2015.

3. Respondent fined his February, 2015 Crum & Forster Indemnity Company and Safety National Casualty Corporation monthly surety reports on Tuesday, March 17, 2015. Respondent filed his February 2015 reports one (1) day late.

4. July, 2015 monthly bail bond reports were due to be filed with the Commissioner by Monday, August 17, 2015.

5. Respondent filed his July, 2015 Crum & Forster Indemnity Company and Safety National Casualty Corporation monthly surety reports on Tuesday, August 18, 2015. Respondent filed his July 2015 reports one (1) day late.

6. October, 2015 monthly bail bond reports were due to be filed with the Commissioner by Monday, November 16, 2015.

7. Respondent filed his October 2105 Crum & Forster Indemnity Company and Safety National Casualty Corporation monthly surety reports on Wednesday, November 18, 2015. Respondent filed his October 2015 reports two (2) days late.

CONCLUSIONS OF LAW

1. The allegations are found to be true and correct, and Respondent has violated 59 O.S. § 1310(A) (2) and (24), 59 O.S. § 1314(B) and OAC 365:25-5-36, by failing to timely file his February, July and October 2015 Crum & Forster Indemnity Company and Safety National Casualty Corporaiton monthly surety reports.

2. Pursuant to 59 O.S. § 1310(B), any bondsman violating a provision of the Bail Bond Act, 59 O.S. §§ 1301-1340, may be subject to a fine of not less than \$250 but not more than \$2,500 per violation.

ORDER

IT IS THEREFORE ORDERED that Respondent Charles David Van Brunt is FINED Two Hundred Fifty Dollars (\$250.00). The fine is to be paid within thirty (30) days of receipt of this Order. If Respondent fails to pay the fine, his license will be suspended and will remain suspended until the fine is paid.

Respondent is further notified that he may request a hearing within 30 days of the receipt of this Conditional Administrative Order concerning this action, and upon such request, the Oklahoma Insurance Department shall conduct a hearing before an independent hearing examiner.

A request for hearing shall be made in writing to Kelley Callahan, Senior Attorney, Oklahoma Insurance Department, Legal Division, 3625 NW 56th Suite 100, Oklahoma City, Oklahoma 73112, and **give an explanation of Respondents' actions alleged herein and any defenses thereto.** If Respondent does not request a hearing within the 30 days allotted, this Conditional Administrative Order shall become a FINAL ORDER on the 31st day following Respondents' receipt of the Order.
