



than Two Hundred Fifty Dollars (\$250.00) nor more than Two Thousand Five Hundred Dollars (\$2,500.00) for each occurrence.

**ALLEGATIONS OF FACT**

1. Respondent failed to timely file his October 2015 American Surety Company (“ASC”) surety report with the Oklahoma Insurance Department (“OID”). Respondent’s October 2015 monthly report was due on November 16, 2015. As of the date of this Order, Respondent has failed to submit the referenced October 2015 monthly report to the OID. Respondent was still licensed as a bail bondsman at the time he failed to submit this required monthly report.

2. Respondent has violated the Oklahoma Bail Bond Code (59 O.S. §§ 1301 et seq.) on a previous occasion in OID administrative case number 15-1280-DIS.

**ALLEGED VIOLATIONS OF LAW**

1. Respondent violated 59 O.S. § 1310(A)(24); by failing to timely file his monthly report as required by 59 O.S. § 1314(B) and O.A.C. 365: 25-5-36.

**ORDER**

**IT IS THEREFORE ORDERED** that Respondent is **FINED** One Thousand Dollars (\$1,000.00). **The \$1,000.00 fine is to be paid within thirty (30) days** made payable to the OID. The \$1,000.00 civil fine shall be paid by money order or cashier’s check.

**IT IS FURTHER ORDERED, ADJUDGED AND DECREED** by the Insurance Commissioner that this Order is a Conditional Order. Unless the Respondent requests a hearing with respect to the Allegations of Fact set forth above within thirty (30) days of the date of mailing of this Order, this Order and the penalties set forth above shall become a Final Order on the thirty-first day following the date of mailing this Order. A request for hearing should be in

writing addressed to Barron Brown, Oklahoma Insurance Department, Legal Division, 3625 NW 56<sup>th</sup> St., Suite 100, Oklahoma City, Oklahoma 73112. The request for hearing must state the grounds for the request to set aside or modify the Order.

Any such hearing shall be conducted according to the procedures for contested cases under the Insurance Code and 75 O.S. § 250-323. If the Respondent serves a timely request for hearing on the Oklahoma Insurance Department, this Conditional Order shall act as notice of the matters to be reviewed at the hearing, and the Allegations of Fact, Alleged Violations of Law, and penalties imposed in this Conditional Order shall be considered withdrawn, pending final resolution at the hearing.

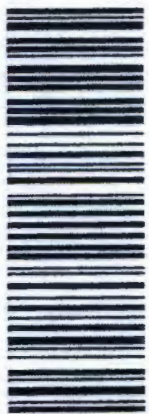
