CONDITIONAL ADMINISTRATIVE ORDER AND NOTICE OF RIGHT TO BE HEARD

COMES NOW the State of Oklahoma, ex rel. John D. Doak, Insurance Commissioner, by and through counsel and alleges and states as follows:

JURISDICTION

- John D. Doak is the Insurance Commissioner of the State of Oklahoma and as such is 1. charged with the duty of administering and enforcing all provisions of the Oklahoma Insurance Code, 36 O.S. §§ 101-7301, and the Oklahoma Bail Bond Act, 59 O. S. §§ 1301-1340.
- Respondent Cary Frost ("Respondent") is a licensed bail bondsman in the State of 2. Oklahoma holding license number 100171315.

FINDINGS OF FACT

- Respondent failed to file his December 2015 NOSURTY report with the Oklahoma 1. Insurance Department ("Department"), which was due Friday, January 15, 2016.
- Respondent's appointment with Raymond Merrill was cancelled on November 4, 2015. 2. Respondent does not have any other appointments. Therefore, a NOSURTY report is required to be filed with the Department.
 - On January 21, 2016, Department staff sent an email to Respondent regarding failure to 3.

file the report.

- 4. On January 25, 2016, Department staff called Respondent and Respondent said that he would work on his report. On January 27, 2016, Department staff called Respondent and left a voice message regarding his failure to file the report.
 - 5. As of today's date, Respondent has not filed the report with the Department.

CONCLUSIONS OF LAW

- 1. Respondent has violated 59 O.S. § 1310(A)(24) for failing to file a report as required by Section 1314.
- 2. Respondent has violated 59 O.S. § 1314(B), which states that "monthly reports shall be submitted electronically to the Insurance Commissioner by the fifteenth day of each month."
 - 3. Respondent has violated 59 O.S. § 1314(D) for failing to pay reviewal fees.
- 4. Pursuant to 59 O.S. § 1310(B), "any person violating any provision of Sections 1301 through 1340 of this title may be subject to a civil penalty of not less than Two Hundred Fifty Dollars (\$250.00) nor more than Two Thousand Five Hundred Dollars (\$2,500.00) for <u>each occurrence</u>."

ORDER

IT IS THEREFORE ORDERED that Cary Frost is CENSURED and FINED Three Hundred Dollars (\$300.00). Respondent is further notified that he may request a hearing within thirty (30) days of the receipt of this Order concerning this action, and upon such request, the Oklahoma Insurance Department shall conduct a hearing before an independent hearing examiner. A request for hearing shall be made in writing to Dan R. Byrd, Oklahoma Insurance Department, Legal Division, 3625 NW 56th St., Suite 100, Oklahoma City, Oklahoma 73112, and state the basis for requesting the hearing.

If Respondent has not paid the fines ordered herein and does not request a hearing within

the thirty (30) days allotted, this Order shall become a FINAL ORDER on the thirty-first (31st) day following the receipt of the Order, Respondent's license shall be immediately suspended, and the fines ordered herein shall be due.
