ORDER LIFTING SUSPENSION

COMES NOW the State of Oklahoma, ex rel. John D. Doak, Insurance Commissioner, by and through his attorney, Dan R. Byrd, and alleges and states as follows:

1. On March 17, 2016, a Conditional Administrative Order and Notice of Right to be Heard was issued in this matter. Heather Mounger (“Respondent”) was fined Two Hundred Fifty and No/100 Dollars (\$250.00). The fine was to be paid within thirty (30) days or Respondent could request a hearing.

2. On May 13, 2016, an Administrative Order was issued in the above referenced matter. Respondent’s license was suspended for failure to pay the fine assessed in the March 17, 2016 Conditional Administrative Order and Notice of Right to be Heard.

3. On May 16, 2016, an email was sent to the Wagoner County District Court informing the Court of the suspended status of Respondent’s license. A copy of the email was sent to Respondent.

4. On May 16, 2016, Respondent paid the fine.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED by the Insurance Commissioner that suspension of Heather Mounger’s bail bond license is hereby lifted.
