

FINDINGS OF FACT

1. On or about September 18, 2015, an appearance bond was executed as follows:

Defendant:	Lorn William Linton
Case Number(s):	CF-2013-807
City/County:	Payne County Court Clerk
Surety:	Shirley Gallahar
Bondsman:	Janice Goad
Power Number(s):	0394
Bond Amount(s):	\$1,000

2. On December 29, 2015, the Defendant failed to appear, and the bond was declared forfeited. An Order and Judgment of Forfeiture was issued and filed in the case on December 29, 2015 by the Payne County Court Clerk. A true and correct copy of the Order and Judgment of Forfeiture was mailed to Respondents on December 29, 2015 with return receipt requested within thirty (30) days after the Order's filing.

3. Gallahar received a copy of the Order and Judgment of Forfeiture on January 28, 2016.

4. Goad received a copy of the Order and Judgment of Forfeiture on January 27, 2016.

5. The ninety-first (91st) day after receipt of the Order and Judgment of Forfeiture was Thursday, April 28, 2016.

6. As of the date of this Order, the bond forfeiture has not been paid or otherwise set aside or the bond exonerated.

7. The Defendant was not returned to custody within 90 days, nor was the face amount of the forfeited bond deposited with the Court Clerk within 91 days, after receipt of the Order and Judgment of Forfeiture by Respondents.

8. The bond was reported.

CONCLUSIONS OF LAW

1. The allegations are found to be true and correct, and Respondents have violated 59 O.S. § 1332 by failing to return the Defendant within ninety (90) days or remit payment in the face amount of the bond forfeiture within ninety-one (91) days from receipt of the Order and Judgment of Forfeiture.

2. Pursuant to 59 O.S. § 1310(B), any bondsman violating a provision of the Bail Bond Act, 59 O.S. §§ 1301-1340, may be subject to a fine of not less than \$250 but not more than \$2,500.

ORDER

IT IS THEREFORE ORDERED that Shirley Gallahar and Janice Goad are each **FINED** Two Hundred-Fifty Dollars (\$250.00).

IT IS FURTHER ORDERED that the face amount of the bond forfeiture shall be deposited with the Payne County Court Clerk (or the bond forfeiture otherwise set aside or the bond exonerated) within thirty (30) days of receipt of this Order. Failure to do so shall result in the **CANCELLATION** of Janice Goad's license privilege and authorization to do business within the State of Oklahoma and **CANCELLATION** of the surety appointment of all surety bondsman agents of Janice Goad.

Respondents are further notified that they may request a hearing within 30 days of the receipt of this Conditional Administrative Order concerning this action, and upon such request, the Oklahoma Insurance Department shall conduct a hearing before an independent hearing examiner. A request for hearing shall be made in writing to Dan Byrd, Assistant General Counsel, Oklahoma Insurance Department, Legal Division, 3625 NW 56th Suite 100, Oklahoma City, Oklahoma 73112, and **give an explanation of Respondents' actions alleged herein and any defenses thereto.**

If Respondents have not paid the fines ordered herein and do not request a hearing within the thirty (30) days allotted, this Order shall become a FINAL ORDER on the thirty-first (31st) day following the receipt of the Order, Respondents' license shall be immediately suspended, and the fines ordered herein shall be due.
