# CONDITIONAL ADMINISTRATIVE ORDER AND NOTICE OF RIGHT TO BE HEARD

Respondent.

COMES NOW the State of Oklahoma, ex rel., John D. Doak, Insurance Commissioner, by and through his counsel, Barron B. Brown, and alleges and states as follows:

#### JURSDICTION AND AUTHORITY

- 1. John D. Doak is the Insurance Commissioner of the State of Oklahoma and, as such, is charged with the duty of administering and enforcing all provisions of the Oklahoma Insurance Code, 36 O.S. §§ 101 et seq., including the Perpetual Care Fund Act, 36 O.S. §§ 7101 through 7112, and the Cemetery Merchandise Trust Act, 36 O.S. §§ 7121 through 7135.
- 2. NorthStar Cemetery Services of Oklahoma, LLC ("Respondent") is a provider of a perpetual care fund and a permitted provider of prepaid cemetery merchandise contracts in the State of Oklahoma, holding cemetery merchandise permit number 862477.
- 3. Pursuant to 36 O.S. § 7110, "[any] person, firm or corporation violating any of the provisions of the Perpetual Care Fund Act shall, upon conviction, be deemed guilty of a misdemeanor and shall be subject to a fine of not less than One Hundred Dollars (\$100.00) nor

more than Two Thousand Five Hundred Dollars (\$2,500.00)." In addition, 36 O.S. § 7134 provides as follows: "[any] organization, or its officers or directors, which violate any provision of the Cemetery Merchandise Trust Act shall, upon conviction, be deemed guilty of a misdemeanor and shall be subject to a fine of not less than One Hundred Dollars (\$100.00) nor more than Two Thousand Five Hundred Dollars (\$2,500.00)."

### **FINDINGS OF FACT**

- 1. Pursuant to 36 O.S. § 7106(A), Respondent was required to submit its 2015 Perpetual Care Trust Fund Annual Report (the "Perpetual Care Report") to the Oklahoma Insurance Department ("OID") by March 15, 2016. Respondent untimely submitted this report to the OID on or about April 15, 2016.
- 2. Pursuant to 36 O.S. § 7128, Respondent was required to submit its 2015 Cemetery Merchandise Trust Fund Annual Report (the "Cemetery Merchandise Report") to the OID by March 15, 2016. Respondent untimely submitted this report to the OID on or about April 15, 2016.

#### **CONCLUSIONS OF LAW**

- 1. Respondent has violated 36 O.S. § 7106(A); by failing to timely file its 2015 Perpetual Care Report with the OID.
- 2. Respondent has violated 36 O.S. § 7128; by failing to timely file its 2015 Cemetery Merchandise Report with the OID.

#### ORDER

IT IS THEREFORE ORDERED that Respondent has violated 36 O.S. §§ 7106(A) and 7128 and is hereby CENSURED and FINED FIVE HUNDRED DOLLARS (\$500.00). The \$500.00 fine is to be paid within thirty (30) days made payable to the Oklahoma Insurance

Department. The \$500.00 civil fine shall be paid by money order or cashier's check. Failure to pay the civil fine or request a hearing within thirty (30) days may result in further administrative action.

Commissioner that this Order is a Conditional Order. Unless the Respondent requests a hearing with respect to the Allegations of Fact set forth above within thirty (30) days of the date of mailing of this Order, this Order and the penalties set forth above shall become a Final Order on the thirty-first day following the date of mailing this Order. A request for hearing should be in writing addressed to Barron B. Brown, Oklahoma Insurance Department, Legal Division, 3625 NW 56<sup>th</sup> St., Suite 100, Oklahoma City, Oklahoma 73112. The request for hearing must state the grounds for the request to set aside or modify the Order.

Any such hearing shall be conducted according to the procedures for contested cases under the Insurance Code and 75 O.S. § 250-323. If the Respondent serves a timely request for hearing on the Oklahoma Insurance Department, this Conditional Order shall act as notice of the matters to be reviewed at the hearing, and the Allegations of Fact, Alleged Violations of Law, and penalties imposed in this Conditional Order shall be considered withdrawn, pending final resolution at the hearing.
